- Update on Accounting conversion

- Property Energy/Electricity
  - Tim Schuetz attended to present electricity bids from United Power Group (broker)
  - Energy rates are increasing so there is a need to evaluate current rates to decide when/if we want to lock in rates and with which company proposed (NRG, Engie, Green Mountain)
  - Choices of fixed rates: 36 month, 48 month, 60 month
  - Our contract ends August 2024 new rate will take effect
  - We will receive money back from being taxed past two years
