FOR A TRANSFORMATIVE JUSTICE APPROACH

[EVERYONE IS WELCOME TO SIGN]¹

As undergraduate and graduate students in the Anthropology and African and African American Studies (AAAS) departments at Harvard, the issues that were made public by the <u>Crimson article</u> were horrifying but unsurprising to us. **We believe every one of the courageous persons who have come forward in one way or another.** This is merely the tip of an immense iceberg of suffering and abuse which far surpasses the individuals named in the article, as other accusations emerge. Because we know, intimately and at varying degrees, some of the magnitude of the problem:

WE REFUSE stalling, denial and pacification campaigns. WE REFUSE the more insidious pacification which often follows the failure of the above, that is, the institution's use of the legitimate indignation perpetrators inspire as foils to rid itself of its complicity.

We use "complicity" in the strongest sense. We are confronted with institutional predators: that is, the setting of the US imperial university changes the nature of predators and we are yet to reckon with the full extent of what this means. These are not merely perpetrators sheltered by institutional incompetence, but perpetrators whose seemingly boundless reach draws from the very logic of universities founded on stolen land,² stolen people and stolen labour.

We can keep feeling outrage at how entire systems repeatedly fail to support victims/survivors/those who are harmed³, or we can start seeing failure as a mechanism rather than a dysfunction. The only way to repair the harm done to us and countless others is (1) taking the full measure of the endemic and systematic nature of a problem which encompasses multiple forms of abuse, including sexual, and (2) committing to address it through transformative justice.⁴

We are fully aware that our demands will seem too large and too ambitious to many. We have long learned that to these people, whether they realize it or not, our very breath, our very flourishing, is too ambitious. Our audience is all who are committed to clearing the horizon of the possible, to liberating stifled imaginations, and to building the world anew. We would not have had the courage of these demands if not for the multiple movements of Black liberation throughout the United States and globally, which have exemplified the necessity of refusal. We owe it to past students, we owe it to ourselves and we owe it to future students. We demand nothing short of radical, truly transformative change.

INADEQUATE RESPONSES

Addressing abuse must start with an acknowledgement of complicity from all of us. We should all begin from the assumption that we are implicated in these issues to some degree. Describing the history of abuse in our department will entail describing our own failures and shortcomings as well. Such descriptions will necessarily also include the failures and shortcomings of people we love. We will have to grapple with the fact that a person who treats one of us well may not treat all of us well, and those who experience harm may cause harm in turn. We must cultivate an environment where people are readily, repeatedly and publicly admitting guilt. Let no one shrink from this work because admitting complicity, inaction, or the precise nature of our learning curves seems shameful. The shameful choice at this juncture would be a refusal to acknowledge and learn from these mistakes.

We are wary of the use of privacy as a justification for never discussing difficult topics like abuse. We must all labour to protect the privacy of victims/survivors/those who are harmed while at the same time protecting vulnerable people unaware of individuals against which serious allegations have been made. Against convenient dichotomies, we must affirm the possibility of doing both. We draw attention to the fact that sometimes, a demand for privacy is a demand for privacy within a particular system. Victims/survivors/those who are harmed who have not come forward publicly often do so in the context of a Title IX system that is deeply flawed. The more faculty leverage their power to speak publicly – rather than through hallway rumours and gossip – on incidents of abuse, past and present, in the academy and beyond, in their own graduate training and in ours, in their own research and teaching and in ours, the less unequal the context will be in which victims/survivors/those who are harmed are tasked with the unjust responsibility of coming forward.

The African and African American Studies department has communicated minimally with students and chosen to adopt a language of technicality and strict adherence to legal procedures which have repeatedly been shown to fail students. Furthermore, AAAS believes itself beyond some of the structural issues that affect Anthropology, which should give pause to all departments thinking along similar lines. While purporting to study Black life across the diaspora and in particular on the African continent, the department has a clear overrepresentation of white faculty in African Studies and not a single Black African woman on faculty. To our knowledge, it has never hired one.

The Anthropology department has repeatedly refused to engage students' complaints over the years, operating through private conversations, whispers and half-hearted commitments that were never formalized. The department has failed on multiple occasions to inform students of steps the faculty was taking, preferring instead, to release them to the Crimson first. This choice to salvage its public image instead of being accountable to its students and staff comes at the cost of widening the breach in trust. Since the release of the Crimson article, while there has been an outpouring of support from people outside of the University, faculty in both departments have failed to make public statements in support of all survivors. While we appreciate private or semi-private statements of support from tenured faculty, we need a lot more courage from them. It is unacceptable that undergraduate and graduate students have shown more courage than every single one of them.

Regarding the Anthropology department's proposal of a "Standing Committee for Creating a Supportive Departmental Community": (1) Marginalized students, in particular queer, Black,

Indigenous, non binary, and students of color have been reporting for years on the issues that are now coming to light. These students have taken on a lot of unpaid labor in the program – from confronting egregious curriculums and proposing counter-syllabi to organising diversity training for faculty regarding the need for non gendered bathrooms, as well as facilitating departmental conversations on the colonial visual culture of departmental buildings. Their efforts have been met with little recognition and even further marginalization, gaslighting, and a complete absence of meaningful change. What guarantees do they have that their time will be meaningfully spent in engaging with this committee? (2) A task of this magnitude without pay is the continuation of the logic evoked above and cannot be seen as engaging with us in good faith. (3) The lack of clarification of the decision powers of such committees creates the possibility of yet another empty bureaucratic structure where actual change comes to die, and a waste, again, of precious time.

We want to emphasize that this response should be measured not by the number of days but by the number of years the Anthropology department in particular has been given opportunities to stand in solidarity with victims/survivors/those who are harmed. It has instead shown that it is more committed to protecting and sheltering the colonial and heteropatriarchal culture it is built on.

Finally, the Crimson piece, while thorough and essential, has oriented the conversation towards unhelpful gender essentialisms, which responses from departments have started to enshrine. The issues at hand are far-reaching, complex and cannot be reduced to a need to add more "women". This shields white and cis-women in positions of relative power who have been complicit in enabling abuses and further marginalizes those for whom the abstract category of "women" has long been a site of violence: trans, non binary, Black, Indigenous, and queer students, as well as other students of color. An intersectional approach to this situation and to future hires is a fundamental prerequisite.

DEMANDS

To the Anthropology & the African and African American Studies Departments, we are intentionally making demands without policy recommendations. We will not outline how these changes should be implemented, though we may share such in the future if there are signs of good faith. Part of the process of (re)gaining our trust should be for you to do the job of proposing ways of implementing them. Students have been made to bear the burden of making these departments work for far too long: caring, mentoring and attempting to protect each other from perpetrators you refused to make accountable. Note that we are not asking you to assess the feasibility of these demands. We are asking you to figure out how you are going to make them work.

"Transformative justice is (...) a community process developed by anti-violence activists of color, in particular, who wanted to create responses to violence that do what criminal punishment systems fail to do: build support and more safety for the person harmed, figure out how the broader context was set up for this harm to happen, and how that context can be changed so that this harm is less likely to happen again. It is time-consuming and difficult work (...). It is not grounded in punitive justice, and actually requires us to challenge our punitive impulses, while prioritizing healing, repair and accountability." Mariame Kaba, 2018.

Accountability

- 1. Immediately remove Ted Bestor, John Comaroff and Gary Urton from both departments and the university at large, and revoke any privileges and titles they may hold before the start of the Fall 2020 term, without removing their access to healthcare, as this should be a fundamental and universal right.
- 2. Release a public letter of apology for putting students in harm's way, detailing the timeline of complicities from tenured faculty especially that have enabled perpetrators (e.g. hiring/promoting accused faculty, not warning advisees of ongoing Title IX proceedings or credible accusations). This is not about sanctions on particular individuals. It is a demand for the kind of transparency and accountability that will allow us to better understand the complexities of complicity and how it settles and proliferates. Accountability means not just a single public statement but regular discussion of these matters with professional networks and in classrooms, as well as ongoing issuing of public reflections. Faculty members who do not take the time to do this but occasionally express shock and outrage in meetings will be seen as interested in being on the right side of these issues without doing the work.
- 3. Create appropriately paid committees in both departments, with clear powers of decision and legal protections, to prevent Harvard's administration from circumscribing the review, as they did in the Dominguez case. The committees should be composed of external reviewers as well as representation from the most marginalized members of the department (in terms of race, gender, sexuality, class, status) to carry out three missions:
 - (1) a thorough assessment of all the institutional spaces these individuals have inhabited and headed (universities, funding agencies, professional organisations etc.), to find any instances of harm, abuse and retaliation and trace networks of complicity.
 - (2) a thorough assessment of the factors which have facilitated abuse. This will include reaching out to alumnx and students who have dropped out along the way and establishing a demographic breakdown of such students. This will also include a review of the hiring history of the departments, their curriculums as well as the visual and infrastructural layout of their buildings.
 - (3) publicly release the findings within six months and give recommendations on how to remedy the damage that has been done, in addition to the demands already listed in this document.

Repair

- 4. Create departmental policies to prevent and handle cases of abuse so that:
 - (1) The fact of a public secret or the anonymous reporting of a significant number of vulnerable members of the department (students, administrative staff, untenured faculty) launches an investigation, rather than placing the burden on survivors to make a formal complaint.
 - (2) Interim measures are taken to protect vulnerable members of the department, including removing the accused from all student committees and set up a clear system of support while the investigation is ongoing.
 - (3) All members of the department are informed that an investigation is ongoing and can make informed choices.

- (4) If misconduct is found, the perpetrator is barred from any access to vulnerable members of the department and such access will only be reconsidered after a thorough procedure of transformative justice placing victims' needs at the center.
- **5.** Take departmental responsibility for finding new advisors for impacted students (new hires, people from other departments, or contingent faculty offered higher pay or permanent positions) who are willing to head committees, write reference letters, offer emotional support, etc.
- **6.** Publicly endorse and fight for the demand long made by the Harvard Graduate Students Union to institute a third-party grievance procedure in cases of discrimination and sexual harassment starting with ongoing investigations in the department, as you know very well how the absence of such procedure has failed your own students.
- 7. Fight for making Harvard University commit funds equal or higher to the combined salaries paid to these faculty during their time at Harvard, as well as expected future salaries and retirement payments, towards grassroots organisations⁵ committed to addressing gender based violence in all of the spaces these individuals have had access to because of their institutional status.⁶

Transformation

- **8.** Dismantle the heteropatriarchal cultures which were allowed to thrive in both departments, but also the white supremacist and imperial cultures inextricably linked to it. In particular,
 - Develop practices and structures to address the issue of abuse during fieldwork, in concertation with undergraduate and graduate students. In regard to field schools, this includes instituting clear codes of conduct, training for TAs and instructors, and protections for students enrolled in all field programs.
 - Redesign introductory courses (African Studies, African American Studies, Archaeology and Social Anthropology) as open syllabi-making courses on the model of the <u>counter-syllabus</u> created by a group of students in response to a revisionist, colonial apologist and almost exclusively white Social Anthropology proseminar.
 - Endorse and fight for <u>Tamara Lanier's plea</u> for the return of the images of her ancestors and dedicate resources for further restitution processes against Black and Indigenous dispossession.
 - Remunerate grassroots social justice organisations <u>both focusing on and led by</u> marginalized communities to conduct regular reports on how the scholarship and influence of the departments can be better leveraged to support struggles for dignity in the greater Boston area.
 - Make a thorough assessment of the history of harmful research in both departments: their past and ongoing ties with the furthering of (neo)colonial practices throughout the world and the military industrial complex and its wars within and outside the United States. Figure out how reparations can be made.

- 9. Endorse the Harvard Graduate Student Union's demands for a fair contract to transform the parameters making students structurally vulnerable to predation, such as but not limited to, financial precarity and endemic mentoring neglect. Set up clear processes to hold tenured faculty accountable to students in terms of mentoring and support.
- 10. Abolish the levers of control which contribute to an unequal academic culture of patronage, facilitate discrimination and allow abuse to manifest and foster. Remove recommendation letters from the requirements for all appointments within the departments' jurisdiction (graduate applications, fellowships applications, faculty hires), as one such lever of control central to the abuses narrated in the Crimson article. For graduate school applications, develop careful procedures so that the removal of letters of recommendation do not further marginalize applicants from non-Euro-American and/or non-English language universities.
- 11. Regarding the stratification of the university system⁷:
 - Commit publicly to hiring a cluster of individuals representative of marginalized identities within each respective department AND who have shown a commitment to not only study systems of power but also actively transform them. Commit to strive to do so as much as possible during COVID-related hiring freezes, and to definitely do so afterwards, not prioritizing any other kind of hire until such cluster of individuals have been given non-precarious positions.
 - Promote faculty unions to help protect precarious positions in academia.
 - Institute mechanisms for administrative staff in the department to report their experiences of harm, and a process through which these harms will be addressed, as they should not be excluded from this transformative process.
 - Endorse and amplify movements for abolishing the tenure-process.
- 12. Publicly demand and fight for broader institutional divestment from fossil fuels, prisons, and toxic sovereign debt as part of a broader financial reorientation towards equity. In particular, endorse publicly the Harvard Prison Divestment Campaign.

To Harvard University, the Anthropology department and the African and African American departments, you may very well fall short of these demands. May they serve as a reminder of what decency and repair would have looked like as you congratulate each other for ineffective and unjust

The phrase "university caste system" is sometimes used to describe persistent and strict distinctions between classes of workers at universities in the United States, a usage built on a conceptualization of 'caste' as a traveling analytical category that can be abstracted from its South Asian context. The use of this term certainly points to some key features of the structure we refer to-from the durability of distinctions between classes, to the emphasis on genealogy and inheritance of academic lineage and talent. However, on 6/11/2020 we the authors have decided to retract this and propose an alternative phrase: "stratification within the university system". Naming this form of inequality a "university caste system" (1) risks a trivialization of the specific lived reality of caste-based inequality in South Asia and across the world, which entails severe forms of oppression and violence (from land theft, to the imposition of unfree labor, police brutality, to discrimination in law) (2) obscures the ways in which caste itself is an oppressive force in universities across the world, including in the US, and including at Harvard. Dominant caste control of knowledge production is part and parcel of the project of the imperial university. The majority of South Asian US academics are from dominant castes, with the majority of those being Brahmins. Scholars of oppressed castes, including Dalit, Bahujan, and Adivasi students and faculty, are severely underrepresented in our institutions, and those faculty and students who are present face discrimination. For a statement on caste as a form of discrimination in the US university, (see Brandeis University's formal policy on the matter). Finally, we are grateful to the Dalit, Bahujan, and Adivasi scholars and activists from whom we have learned, and continue to learn. For recent work on caste in the United States we recommend research from Equality Labs.

remedies. May they serve as a public testimony of your inability to align your departmental values with the scholarship you purport to create.

At the very least, we expect from individual faculty in lieu of private statements of powerlessness, <u>public</u> statements testifying to the fact that their hands are tied, that the institutional logic they inhabit prevents them from effectively protecting students and supporting their intellectual growth. Anything short of that is an acknowledgment of continued complicity. **Trust that the refusal to take or give scraps is worldmaking in other ways.**
