REGULATIONS

4. Savings card is valid only for account holder and legal authorizer.
5. Savings card is entitled to ownership transfer and inheritance under the Laws.
6. It is possible for you to use savings card as means of mortgage and loan security at the bank.
7. When the savings card is lost, you must notify ACB immediately to avoid being exploited. You must bear your responsibility for the consequences of such loss.
8. You must keep this savings card carefully and must not erase or amend any content in the savings card.
