INTRODUCTION (FONT SIZE 12, BOLD, CAPITALISED)

This is a model for the authors Journal of English Education and Literature, SINAR LIMA. Under this model, each author(s) is expected to submit a manuscript that includes an explanation of the current study, including the background, problems, and objectives of the study. Authors are encouraged to avoid using bullets, pointers, or numbering instead of the subheading system, and to avoid using first-person (singular and plural) pronouns instead of the third.

This section also includes further processing of previous relevant studies from deeper literature reviews as a theoretical basis. Therefore, writers must use proper citation style. Journal of English Education and Literature requires the use of a specific citation style based on APA style. Read the following example as a reference guide. Author(s) can write: According to Adellia (2023)... or ... (Suadiyatno et al, 2024). You can also write: Irawan (2018) suggested...; or "...", Cuheliana (2020) said, if the author(s) prefer a direct quote. To quote the author of an anonymous journal article, the author(s) may write ...totetis en Tempo (2020). Journal of English Education and Literature recommends using a computer application (APA) to manage citations and references. Approximately the length of this paragraph, the author(s) are only allowed to write an introduction for 15-20% of the pages of the manuscript. Therefore, try to write concisely and precisely.

The author(s) can present written sides to the research questions and present their arguments on the side they would prefer to support. It is also advisable to mention the scope and contribution of the ongoing research to the research field.

The article must be 10-20 pages (maximum 7000 words), single-spaced, 12-point Times New Roman font, without references. Do not make first paragraphs or leave spaces between paragraphs.

RESEARCH METHOD (TIMES NEW ROMANCE, FONT SIZE 12, BOLD, CAPITALISED)

This section includes the author(s) in sufficient detail about the study preparation for data collection and processing. The author(s) must submit a chronological report of the research, covering the preparation of the research material, planning and research activities. In addition, an explanation is needed about the methods used in the research. This part fills 10-15% of the manuscript. (Times New Romance, font size 12, single spaced). Research method also covers: (1) Research design (Times New Romance font size 12, bold). This sub section contains statements by the authors about the design of the research, which was chosen from one of three approaches. Each approach provides different research agendas for different research agendas. For example, in quantitative research there are pre-experimental, real-experimental and quasi-experimental research designs. At the same time, qualitative and mixed methods offer other models. This subsection should be part of the methods section. Therefore, it also provides a brief description of the variables under study. (2) Population and Sample OR Subject* (Times New Romance, font 12, bold). In a quantitative study, this section is used to indicate the population and sample or number of subjects selected for qualitative research. Please indicate your technique and/or parameters when selecting a sample and subject. Additionally, in a study using study groups, write briefly about grouping. (* Use population and sample in quantitative method and qualitative research in the subject, if necessary, skip one of the subsections). (3) Instruments (Times New Romance Font Size 12, Bold). Tell us briefly about your data collection tool. Indicate whether the results of the pilot studies led to changes in the current study. Therefore, authors should briefly describe the equipment, instruments, or measuring devices used, including the model number and manufacturer. A detailed description should be defined chronologically of which actions were taken and by whom. (4) Data Analysis (Times New Romance font size 12, bold). In the Data Analysis subsection, the author(s) must process the data from the previous step. A different method can lead to a different data processing model. For quantitative research, the author(s) should show how they calculated the derived variables (to deal with outliers and missing data). Therefore, he must summarize the information. Analysis using software should be completed with details (software name and version). For statistical tests, give reference to less commonly used tests and what was compared. A critical alpha probability (p) at which differences or associations were considered statistically significant was also proposed. For qualitative research, authors should mention the model used to analyze the data. This brief explanation is followed by the implementation of each step in the selected model.




Figure 1. Number of subtheme published in Jo-ELT

To support the answer, the author(s) will explain, showing the importance of the findings described earlier in this section. The author(s) are also encouraged to show how the answer(s) correspond to existing knowledge on the given topic. In addition, the author(s) may use this space to communicate their interpretations and opinions, which include the author(s) rationale for relevant findings, recommendations for future research, and clinical implications of the results. The discussion should be developed briefly, yet clearly and fully, stating, supporting, explaining and defending the answers to the questions and other important and relevant questions. The main principle is to be specific and focus on delivering a specific message. Please note that this subsection contains comments, not a repetition of observations.

CONCLUSION (TIMES NEW ROMANCE, FONT SIZE 12, BOLD, CAPITALISED)

In this section, the author(s) should **present their opinion on the main results** and implications of the study, but not **on the entire study**. **No new information is brought to the conclusion.**

REFERENCES (TIMES NEW ROMANCE, FONT SIZE 12, BOLD, CAPITALISED)

Use APA for in-text references and bibliography (Hanan et al, 2024). In the case of in-text citations, use the name and year of the author (Author, 2021), and in the case of direct citations, use the page number" (Author, 2010). If you cite more than one reference, put them in alphabetical order (Alfa, 2022; Beta, 2023). If the reference has up to five authors, first use all names (Author1, Author2, Author3, Author4 and Author5, 2024) and then the first author et al. then (Author1 et al., 2024). Do not use footnotes.
