ETS is responsible for certain test development with the STARR program. We do Grades 3-8 Math and Reading and Grade 8 Social Sciences as well as U.S. History, Algebra I, World

Geography, World History, Geometry and Algebra II.

Much of the test development is done in the state of Texas through our San Antonio office although some test development takes place at ETS's headquarters in New Jersey too. We typically assemble test development committees composed of Texas educators and content experts to help us write and create the questions. Once the content is agreed upon and the questions written, we turn them over to our colleagues at Pearson who create the test forms. We review the assembled forms and other quality control responsibilities in cooperation with Pearson but that's pretty much it.

Here's some additional information that may be helpful.

Pearson has 1,800 Texas-based employees (they do not all work on the Texas contract). Item development for the Texas contract is handled by three subcontractors (all based in Texas).

a) Educational Testing Service (K-12 Education Division, based in San Antonio, TX) --

Reading: grades 3-8

Mathematics: grades 3-8, Algebra I, geometry, Algebra II

Social Studies: grade 8, world geography, world history, U.S. history

b) Lone Star (based in Austin, TX) [HUB] --Reading: English I, English II, English III

Writing: grades 4, 7, English I, English II, English III Science: grades 5, 8, biology, chemistry, physics

c) Tri Lin (based in San Antonio, TX) --Reading (Spanish): grades 3-5 Writing (Spanish): grade 4 Mathematics (Spanish): grades 3-5 Science (Spanish): grade 5

These subcontractors are just the first stage of item development. Once items are drafted, they then go through extensive review and editing by TEA and committees of Texas educators.
