Canal Winchester High School CCP FAQ's

WAIT! Have you watched the <u>CCP INFORMATIONAL VIDEO 2025-26</u>? Many of the questions you may have can be answered by watching the video. In order to participate in the CCP program for the 2024-2025 school year, students and families are required to receive counseling concerning CCP by watching the video. **ADVISEMENT IS A REQUIREMENT TO PARTICIPATE**. This video covers all topics related to CCP.

Q: What is College Credit Plus (CCP)?

College Credit Plus is Ohio's dual enrollment program that gives students an opportunity to be enrolled in both high school and college course work at the same time. Eligible students can take a course and earn high school and college credit that appears on both their high school and college transcripts, called dual credit.

Q: How are College credits converted to High School credits?

3+ college semester credits = 1.0 high school credit 2 college semester credits = 66 high school credit 1 college semester credit = .33 high school credit

Q: How will college credits earned in high school transfer to colleges/universities students will attend after high school graduation?

Many courses earned through the College Credit Plus program are transferable to public institutions in Ohio. Colleges might consider courses on a case-by-case basis to try to find an equivalent at their institution. Students can visit this <u>website</u> to check transferable credits between colleges.

Q: What Colleges/Universities Offer CCP Courses?

All public universities in Ohio offer CCP programs that students may participate in. Some private colleges and universities also participate in CCP, but you will need to check with that individual school. Our most popular college and university providers are listed on the CWHS CCP website.

Q: How many credits is a student permitted to take each year (maximum credits)?

Students are limited to a maximum of 30 semester credits per academic year, including both college and high school credits. Students wishing to earn more than 30 semester credits per academic year will be responsible for the cost of attendance for each credit above the 30 maximum credit limit. Maximum credit hours for each student are determined by the formula below.

30 – (high school only credits x 3) = Maximum number of CCP credit hours a student can take each vear

Q: What is FERPA (Family Educational Rights and Privacy ACT)?

If a student is attending a postsecondary institution – at any age – the rights under FERPA are transferred to the student. CCP students are college students and are subject to FERPA. If a CCP *Updated 11/2024*

student would like to waive their FERPA rights and share information with parents/guardians, they must sign a FERPA waiver through the college/university.

Q: How do students acquire their required textbooks for a CCP course?

College Credit Plus law states that the School District in which the student attends is responsible for providing instructional tools (textbooks) for CCP students. Please read the CWLS CCP Textbook and Resource Policy. Then sign and return the form to the school counseling office by April 1st, 2025.

Q: What happens if a CCP student fails or withdraws from a course?

If a CCP student fails or withdraws too late from a college course, the district can require families to repay the district for the costs. The repayment will be added to students' fees. This grade will go on the students' high school and college transcript.

Students with a college GPA below a 2.0 will be placed on CCP probation. Students who do not improve their college GPA to a 2.0 in the next semester that they take CCP courses, will be placed on CCP dismissal.

Students may submit an appeal for CCP Probation and Dismissal.

Probation/Dismissal Appeal Paperwork

Q: How does a student take a Placement test or send in qualifying placement test scores for courses at any other college or university?

Placement tests are given to determine students' proficiency in order to place them into the correct college level courses. If students wish to send qualifying ACT/SAT scores, they must be sent directly from the testing website to the college or university. If a student needs to complete a placement test (Accuplacer/ALEKs etc.), they will need to check with the college or university on how to take the test. CWHS will offer one placement test (Accuplacer only) in the spring for students who need to take a placement test.

Q: How does a student take a placement test or send in qualifying placement test scores for embedded Columbus State Courses at CWHS?

If students wish to send qualifying ACT/SAT scores, they must be sent directly from the testing website to the college or university. If a student needs to complete a placement test (Accuplacer/ALEKs etc.), they can register to take the test by registering on the CSCC <u>placement testing website</u>. CWHS will offer one placement test (Accuplacer only) in the spring for students who need to take a placement test.

Q: What is the process for students to participate in embedded Columbus State CCP classes at CWHS?

Follow the steps in the CCP Embedded Course Checklist.

Q: What is the process for students to participate in CCP at another college or university?

Follow the steps in the CCP Checklist for Online or On Campus Courses.

Q: My student participates in school sports. How do CCP classes factor into athletic eligibility?

Student athletes should learn the Ohio High School Athletic Association (OHSAA) requirements. Summer term CCP courses cannot be used to bring a student into compliance with the OHSAA requirements for interscholastic athletic participation. Students must be **passing 5 classes** (PE is excluded) and have a **1.65 GPA** to participate in sports at CWHS. A 3+ credit hour CCP class is the equivalent of 2 HS courses of eligibility.

Example: Jeremiah is a senior who plays on the CWHS soccer team. He is taking English 12, Forensic Science, Ceramics and MATH 1148 (a 4 credit hour CCP class) during fall semester. He is in 3 high school classes and 1 CCP class that is 3 credit hours or more (equivalent to 2 high school courses). Jeremiah is enrolled in the equivalent of 5 high school courses for fall semester and is eligible for soccer if he is passing all classes and meets the 1.65 GPA requirement.
