# 1. INTRODUCTION GARAMOND 14pt

The introduction should briefly place the study in a broad context and highlight why it is important. It should define the purpose of the work and its significance. The current state of the research field should be reviewed carefully, and key publications cited. Please highlight controversial and diverging hypotheses when necessary. Finally, briefly mention the main aim of the work and highlight the principal conclusions. As far as possible, please keep the introduction comprehensible to scientists outside your particular field of research. The introduction should contain the background to the problem; and objectives. Based on the proper ratio of the article length (4000-6000 words), the introduction should not be too extensive, about 30% or 1500 words or 2 pages.

Introduction refers to some literature that becomes the basis for the theory or research reasons. The author should explain the research problems accompanied by data so that it becomes the urgency of the research. In the next paragraph, the author describes at least five previous studies that are relevant to the manuscript-under-research topic. From the previous studies, the authors can explain the gaps and research differences, so that they can formulate a state of the art or research novelty. References should be cited as (Kamba, 2018) or (Marchlewska et al., 2019) or (Cichocka, 2016; Hidayat & Khalika, 2019; Ikhwan, 2019; Madjid, 2002) or (Miller & Josephs, 2009, p. 12) or Rakhmat (1989). See the end of the document for further details on references. Technical and local/tribal terms should be defined the first time they are used. Symbols, abbreviations, and acronyms should also be defined. All tables and figures should be cited in numerical order. Paragraphs are arranged in such a way, with the settings on Spacing (before = 0pt, after = 6pt). Line Spacing is set at 1.15 spaces. Between the sections are 1 beat distance. Garamond 12pt.

In research articles, the last paragraph (method) contains an explanation of the research approach, subjects of the study, the conduct of the research procedure, the use of materials and instruments, data collection, hypothesis (if any), and analysis techniques.

The results obtained from the research have to be supported by sufficient data. The research results and the discovery must be the answers, or the research hypothesis stated previously in the introduction part.

# 2.1. Heading 2 for subsection Garamond 14 Italic

In the first sub-chapter, the author explains the theoretical framework of the research that is relevant to the discussion. Theory must be operational, in the sense that the theory used is by the research topic. The theory is quoted from primary references and strengthened by developer theory obtained from secondary references. It is not allowed to review theories at length if they are not related to the discussion.

The main text under Heading 3 section should be arranged in such a way, with the settings on Spacing (before = 0pt, after = 6pt). Line Spacing is set at 1.15 spaces. Before text indentation is 0,75cm, and so on.

# 2.2. Figures, Tables and Schemes




Figure 1. Relation of tarekat, syariat, and hakikat




Figure 2. This is a figure, schemes follow the same formatting.

In the second subchapter, the author explains the exposure of the research data. The data is presented in tabular form for the APA 7th Edition model and is accompanied by accurate references. Data presentation must use triangulation techniques (observation, interviews, and documentation) except for literature research. Tables and figures are referred to in paragraphs as Table 1 or Figure 1, not "the Table below" or "the following figure". As in Table 1, which discusses general information on article submission in IJITECH, or Figure 1 which explains the relation of syariat, tarekat, and hakikat, or Figure 2 which explains the setup for multiple panel figures.

# 2.3. Discussion. A term or the topic is highlighted on the title if needed

In the third sub-chapter, the author describes the data analysis, discussion, and research reasoning. In this subchapter, the author is also required to review the research topic in depth by considering the theory tools and research data. The author also has to dialogue the results of research findings with several other relevant research findings. Do these findings corroborate other research or criticize other research? Then ends with the author's idea independently.

Authors should discuss the results and how they can be interpreted from the perspective of previous studies and of the working hypotheses. The findings and their implications should be

discussed in the broadest context possible. Future research directions may also be highlighted. The following components should be covered in the discussion: How do your results relate to the original question or objectives outlined in the Introduction section (what/how)? Do you provide interpretation scientifically for each of your results or findings presented (why)? Are your results consistent with what other investigators have reported (what else)? Or are there any differences?

#### 3. CONCLUSION

The conclusion should answer the objectives of the research/review and its discoveries. Within a single and up to three paragraphs, the concluding remark should not contain only the repetition of the results and discussions or abstract. You should also suggest future research and point out those that are underway. The conclusions are written straightforwardly and should be the direct answer to the research question, and not expressed in statistical sentences. A fair proportion is 10 percent of the total article.

In conclusion, there are no more citations, unless absolutely necessary and under impossible circumstances. In general, the number of references or references in the articles in IJITECH is at least 20 titles and a maximum of 40 titles with the largest proportion; 75% of which comes from primary sources (journal articles of the recent ten years).

## **GUIDELINES ON REFERENCES**

The literature listed in the References contains only the sources referenced or included in the article. We recommend preparing the references with a bibliography software package, such as Mendeley, EndNote, Reference Manager or Zotero to avoid typing mistakes and duplicated references. Referral sources should provide no least than 75% of journal articles, proceedings, or research results from the last ten years. Reference and citation writing model uses the 7<sup>th</sup> edition of APA (American Psychological Association) Style.
