

Terms of Service

Razormaw's Written Commissions

Updated October 3rd, 2023.

By filling out the commission form, you agree to these terms. It is your responsibility to have read and understand them before placing an order. Failure to do so does not exempt you from these terms.

Any exceptions to these terms must be granted in writing through verified channels of communication. These include:

Payment and Cancellations

1 – All prices are listed on my commission order form as well as my Furaffinity account. If there are ever any inconsistencies between them, the prices listed on my commission order form are the final rates.

2 – All prices are posted in USD and must be paid in such. No exceptions.

3 – Prices are subject to change for any reason without prior notice. Orders placed before the changes are subject to the prices as posted on the commission order form at the time of order.

4 – Payment is required in full, up front through a PayPal invoice. There are no exceptions to this rule. Work on your commission will not commence until payment is received.

5 – If you wish to cancel your commission, you must do so before paying the PayPal invoice. There will be no refunds offered once payment is received and work on a commission has begun.

6 – Commissions still awaiting payment after one week will receive a one-time reminder that the invoice must be paid before work can proceed. One week after that, the commission and invoice will be canceled.

7– Any orders placed by clients known to be under 18 years of age at time of ordering will be rejected, regardless of the content of the commission. By placing an order, you verify that you are at least 18 years of age and may legally view and purchase pornographic materials in your country and region.

Process

8 – All clients *must* fill out the Written Commission Form in full to place an order, even if details have been discussed elsewhere.

9 – After reviewing any given request and accepting the commission, I will send a PayPal invoice to the address included on the commission form.

10 – Upon receipt of payment, you will be given a spot in my queue on Trello. Anonymity is available on request but your commission will still be added to the queue without your name.

11 – Work will not commence until payment is received. Partial or in-progress drafts/previews will not be provided.

12 – A completed draft will be delivered to you through Google Docs. I provide time estimates for work on request and will inform you of any delays, but these estimates are not to be considered binding.

13 – All requests for edits may be entered into the Google Doc document itself, or provided as a list elsewhere. See my edit policy below for more details.

14 – Once edits are completed, I may post the story to Furaffinity and crosspost to Twitter, unless you prefer to keep the story private. I reserve the right to post to other websites without notice, with the exception of any story requested to be private.

Edit Policy

15 - All edits are offered in good faith and within reason. I reserve the right to refuse edits that constitute re-writing the story, but will do my best to ensure the final product meets your satisfaction.

16 – If your chosen edits require a significant expansion to the final word count beyond the maximum value of your order, or a major revision which involves re-writing a large amount of words, I reserve the right to request additional payment to continue the process.

17 – If upon completion of a draft you wish to upgrade to a higher tier, you may request such and an additional PayPal invoice will be sent equaling the difference in pricing tiers.

18 – I reserve the right to refuse suggested edits for any reason, including adding details which were not listed on the original order form.

19 – If a client is unresponsive without notice of their absence for over one week following delivery of the first draft, further edits may not be provided at my discretion.

Content Policy

20 – The artist retains the right to refuse any commission for any reason, even if its contents otherwise are acceptable within these stated guidelines.

21 – Under no circumstances will a commission be accepted if it includes any of the following:

 -- Gore, scat/watersports, incest, underage characters, zoophilia, racism/hatred, real people

22 – If content does not fall within the above, but is still considered extreme or offensive to some, I reserve the right to request a commission not be posted publicly upon completion.

23 – You retain all liability when trademarked or fan characters are being depicted. You may not request the depiction of a personal character that does not belong to you unless permission has been granted by that character's owner. If the story is intended as a gift, use of the character will be considered on a case by case basis.

Display and Usage Rights

24 – As long as permission has been granted on the commission form, the artist may share and display the completed work on any website chosen. I am not required to do this and may remove stories from display at any time, for any reason. Links will be given to your personal accounts as available unless otherwise requested.

25 – Unless requested otherwise, you may repost any completed commission to your own personal website or galleries, but only if the text remains unedited from its final delivered form and only if credit and a link is provided to my Furaffinity page and Twitter account. Reposting commissioned writing for the purpose of financial gain is prohibited. If the client wishes to make further edits beyond those provided by the artist, permission must be granted by the artist to post the work on any website or gallery.

26 -- The link to the document which contains the original text of each story is for the customer's personal use only. Access to this document will be revoked if the link is found to have been shared publicly. The client may request a text file of a completed commission for sharing or backup purposes.

27 – The client retains the right to all characters being depicted, unless the characters being depicted belong to the artist or a third party.
