Prepare for Your State's Changes/Legal Protection

- 1. Everyone in trigger ban states needs to figure out their legal reality NOW so you don't panic and freeze when a patient needs you. *Do no harm* means knowing how to provide autonomy in the face of laws that treat an ectopic like a normal pregnancy, etc. The "life of the mother" is a vague issue (see abortion in Ireland for examples of a woman dying because doctors were more worried about a law than a person's life https://en.wikipedia.org/wiki/Death of Savita Halappanavar).
- 2. And if you have Conflicting laws (ie: Arizona has a new 15 week ban that hasn't gone into effect, and an 1800s law "that calls for mandatory prison time for providers who perform the procedure at any point in a pregnancy.") you need to know what they are. Are you a fourth year? Apply to RHEDI residencies, and ASK about abortion training in your interviews. https://msfc.org/resident-opportunities/ Is it opt-out? Are "morally opposed" residents still required to learn about abortion? What about contraception? What's their plan post RvW - do they have plans to get real hands-on training for you out of state? Where is the funding coming from for your travel and lodging for that training? How is the residency program or their attendings fighting for local patients access to care? Do they work with any abortion funds or reproductive justice organizations?

If your program doesn't have plans to discuss abortion in didactics/teaching this year, push for a change to get it covered. For procedure training, demand an abortion training MVA papaya procedure clinic (MSFC can help with this). Or, give your own talk! In my program, senior residents were assigned specific didactics, but you can push to teach an important and presently relevant topic. I taught about the history of abortion in Arizona (yikes), the basics of abortion types + the costs, ethics (what Crisis Pregnancy Centers do, it's ok to feel uncomfortable with a medical procedure but not to lie or fail to refer), and present day laws in our state (mandatory waits, rules for minors, insurance restrictions.

You can learn abortion on your own. If you can't get in person training you can use an elective to create your own, (see FM Abortion Elective Goals & Objectives to get started) and RHEDI's training courses (https://rhedi.org/education/rhedi-curriculum/). RHEDI's education section also has training on reproductive justice, options counseling and contraceptive care, if you want to do a full "abortion and family planning" elective. There's also continuing education and abortion training via the Reproductive Health Access Project -

"The main finding of The Turnaway Study is that receiving an abortion does not harm the health and wellbeing of women, but in fact, being denied an abortion results in worse financial, health and family outcomes."

<u>Mass Beyond Roe</u> has recommendations for legislative action, budget investments, and regulatory solutions that leaders and policymakers should adopt today. This is a great framework for those who want to make local change to protect and expand abortion access in your state. The Supreme Court destroyed federal protections, but groups have been eroding access since the 80s. *Let's fight back the way they will continue to - on the ground, with local laws.*
