Articles published in *QAWA'ID: Journal of Arabic Language and Literature* are original research contributions in the fields of Arabic language, linguistics, and Arabic literature. The abstract must be written in a single paragraph (200–250 words), covering the background of the problem, research method, main findings, and conclusion. The abstract must be written in both proper Indonesian and English.

Keywords: keyword one, keyword two, keyword three (3–5 keywords, Cambria 10 pt, italic if necessary)

INTRODUCTION (Cambria 12 pt, 1.5 spacing)

This section should elaborate the academic background, research problem, and the urgency of the topic. The writing must be narrative and supported by recent and relevant literature. Avoid generalizations; instead, highlight the research gap, originality, and the scholarly contribution offered by the article.

Example of body note:

In contemporary literature development, modern Arabic linguistic discourse requires the integration of both historical and structural approaches (Abdullah 2023, 78).

RESEARCH METHOD (Cambria 12 pt, 1.5 spacing)

This section should describe the research approach, design, data sources, data collection techniques, and data analysis methods. Present the description concisely, yet clearly and comprehensively.

RESULTS AND DISCUSSION (Cambria 12 pt, 1.5 spacing)

Present the findings of the study and discuss them scientifically. Use subheadings if needed, including tables or figures (if relevant). Apply critical analysis, compare the findings with previous studies, and highlight the scholarly contribution.

CONCLUSION (Cambria 12 pt, 1.5 spacing)

The conclusion must address the research problem and narratively present the implications of the findings (not in bullet points). It should provide a strong and clear closing statement.

At least 80% of the references must come from the last five years, following the *Chicago Manual of Style 17th Edition (full note)* with a body note system. Use Zotero/Mendeley as the reference manager.
