KHUSAYSA DHAMAAN DADKA QABA NAAFANIMADA SOCODKA: Haddii aad isticmaashay, ama aad isku dayday inaad isticmaasho, jidka qaybta lugaynta ee magaalada Boston oo aad la kulantay koonayaal dhinacyada iyo jidad kale ee lugaynta ah ee ka maqan dariiqyada, ama marinnada dariiqa ee aan la geli karin sababta oo ah way waxyeeloobeen, iyagoo u baahan dayactir, ama haddii kale xaalad aan ku habboonayn ama ku filnayn in la isticmaalo, waxaad noqon kartaa xubin ka tirsan Kooxda Dejinta la soo jeediyey ee ay dacwaddan saamaysay. Kani waa ogeysiis maxkamaddu fasaxday.

"Naafada Dhaqdhaqaaqa" waxaa loola jeedaa naafonimo ama xaalad caafimaad oo xaddideysa awoodda qofka inuu ku socdo, dhaqdhaqaaqo, ku wareegi karo walxaha, ama kori karo ama ka degi karo jaranjaro ama goob kala koreysa. Qofka leh Naafonimada Dhaqdhaqaaqa wuxuu isticmaali karaa ama isticmaali karin kursiga curyaamiinta, iskuutar, aaladda dhaqdhaqaaqa elektorooniga ah ee shaqsiyadeed, biraha curyaanka, biraha lagu socdo, ul, bakooraad, qalabka lafaha, ama qalab la mid ah ama aalad si ay uga caawiso gudbitaanka marinka lugaynta, ama waxay noqon kartaa qof socodka naafo ka ah.

OGAYSIISKA DACWAD WADAREED

Ujeeddada ogaysiiskan ayaa ah in lagu wargaliyo heshiis la soo jeediyey oo ku saabsan dacwad ficil ah oo heer fasal ah oo la keenay iyada oo loo metelayo shakhsiyaadka leh Naafonimada Socodka oo ka dhanka ah Magaalada Boston. Xal u helida heerka waxqabadka waxaa lagu qeexay dukumenti la yiraahdo "Amarka Ogolaanshaha ee La Soo Jeediyay." Amarka Ogolaanshaha ee La Soo Jeediyay, ee ay tahay inay ansixiso Maxkamadda Degmooyinka Maraykanka kahor intaanay dhaqan-gelin, ayaa lagu gaadhay kiiska cinwaankiisu yahay *Muehe et al. v. City of Boston*, Case No. 1:21-cv-11080-RGS, oo laga xareeyay Maxkamadda Degmada Maraykanka ee Degmada Massachusetts.

MACLUUMAADKA AASAASIGA AH

Dacwadani waxay sheegaysaa in Magaalada Boston ("Magaalada") ay jabineyso sharciyada gelitaanka naafada ee federaalka iyadoo ku guuldareysatay inay rakibto oo ay dayactirto dariiqyo ku filan si loo hubiyo in dadka qaba Naafada Socodka ay heli karaan xaqoodaa dadka lugeynaya. Magaaladu way ka dooddaa eedeymahan waxayna beenisay inay ku tumatay sharciga.

Tani waa dacwad wadareed. Dacwad wadareedkan, mid ama in ka badan "Wakiillada Wadarta ah" ayaa ku oogaya dhammaan dadka leh sheegashooyin sharci oo la mid ah. Xaaladdan oo kale, Wakiilada Dacwad Wadareedka waa Michael Muehe, Elaine Hamilton, Crystal Evans, iyo Colleen Flanagan, kuwaas oo muddo dheer degganaa magaalada Boston ama booqday dad leh Naafonimada Socodka. Dacwad wadareedka, hal maxkamad ayaa u xallisa arrimaha

dhammaan Xubnaha Kooxda Dacwoonaya. Garsooraha Degmada Mareykanka Stearns ayaa mas'uul ka ah dacwad wadareedkan. Maxkamaddu ma aysan go'aansan inay caawiso kiiskan wakiilada ama Magaalada. Taas badalkeed, labada dhinacba waxay isku raaceen heshiis.

HESHIISKA DACWADA

Heshiiska Dacwada waxaa ku jira dhammaan dadka qaba Naafanimada Dhaqdhaqaaqa (oo ay ku jiraan dadka deggan iyo/ama booqdayaasha Magaalada Boston) kuwaasoo, waqti kasta ka hor xukunka maxkamadda ee oggolaanshaha ugu dambeeya ee dejinta, loo diiday helitaanka buuxa iyo maritaanka loo siman yahay ee jidka lugaynta ee magaalada sababo la xiriira dhagaxaan dariiqa oo aan jirin ama aan la geli karin.

SOO KOOBAN AMARKA OGGOLAANSHAHAA EE LASOO JEEDIYAY

Waxyaabaha soo socdaa waa soo koobista qodobbada qaarkood ee soo-jeedinta amarka Oggolaanshaha ee lasoo jeediyay. Si aad u hesho nuqul ah Amarka Oggolaanshaha oo dhammaystiran, ka eeg qaybta "Macluumaad Dheeraad ah" qaybta hoose.

Wareegtada Oggolaanshaha Oggolaanshaha waxay u baahan tahay Magaalada inay rakibo ama cusboonaysiiso celcelis ahaan 1,630 dariiq sanadkiiba illaa laga gaarayo dariiqa laga soo galo oo buuxiya heerarka marin-u-helidda naafada ee federaalka oo laga helayo gees kasta oo ka mid ah waddada lugeynta. Iyadoo lagu saleynayo qiyaasaha ugu wanaagsan ee Dhinacyada, tani waxay dhici doontaa dhammaadka 2030.

Magaaladu waa inay rakibtaa ama cusboonaysiisaa jidadka markay dhisayso jidad cusub. Sidoo kale, marka Magaaladu dib u soo cusbooneysiiso jidadka, waa inay dhisaan ama cusboonaysiiyaan dariiqyada ku dhagan jidadka. Magaaladu waa inay mudnaan siisaa dhisida ama cusboonaysiinta jidadka luuqyada ah ee u dhow xarumaha dowladda, dugsiyada, beeraha, jidadka gaadiidka, goobaha caafimaadka, ganacsiyada, goobaha shaqada, iyo xaafadaha la deggan yahay, siday u kala horreeyaan. Waa inay abuurtaa “Qorshaha Hirgalinta” oo tixgalinaya mudnaantan isla markaana fursad u siinaya dadweynaha inay ka faaloodaan Qorshaha hirgelinta.

Amarka Oggolaanshaha ee lasoo jeediyay ayaa sidoo kale ku ballanqaaday Magaalada inay sii waddo ilaalinta nidaamka iyada oo loo marayo dadka Naafada Socodka ay u soo gudbin karaan codsiyo ah in Magaalada ay ka dhiso ama kor u qaaddo marinnada meelaha gaarka ah. Magaaladu waxay adeegsan doontaa dadaalkeeda ugu fiican si ay u baarto codsi kasta 30 maalmood gudahood iyo inay ku dhiso ama kor u qaaddo jid kasta oo laga codsado socodka hal sano gudahood marka la soo gudbiyo. Macluumaadka ku saabsan sida loo soo gudbiyo codsiga dariiqyada ayaa si guud looga heli doonaa websaydhka Magaalada (cityofboston.gov/311).

Magaaladu waa inay dayactirtaa dhammaan jidad si habsami leh u shaqeynaya, marka laga reebo carqaladeyn ku meel gaar ah dhismaha awgiis, dib u hagaajinta, ama dayactirka. Marka jidadka si kumeelgaar ah loo heli waayo, Magaalada ayaa bixin doonta wado kale oo marin u ah dadka Naafada Socodka qaba. Intaas waxaa sii dheer, Magaalada waa inay adeegsataa dadaalka ugu fiican si loo hubiyo in waqtiga saxda ah looga saaro barafka iyo qashinka kale

meelaha dariiqyada ah iyo meelaha laamiga ah iyada oo loo marayo sii wadida fulinta sharciyada magaalada isla markaana si degdeg ah uga jawaabto cabashooyinka la xiriira biyaha fadhiya bartamaha dariiqyada.

Amarka Oggolaanshaha ee la Soo jeediyay ayaa sidoo kale u baahan Wakiillada iyo qareennada matala Heshiiska Dacwada ("La-Taliyaha Dacwada," ee hoos lagu caddeeyay) si ay ula socdaan u hoggaansanaanta Magaalada ee amarka Oggolaanshaha la soo jeediyay. Magaaladu waa inay soo saartaa warbixinno sanadle ah oo diiwaangeliya dhisida iyo casriyaynta jidadka.

SII DEYNTA SHEEGASHO

Xeerka Oggolaanshaha La soo Jeediyay ayaa xallinaya oo sii deynaya, illaa dhammaadka Muddada Amarka Oggolaanshaha la soo Jeediyay, dhammaan sheegashooyinka amarka, caddaynta, ama gargaarka kale ee aan lacagta ahayn ee la keenay, waa la keeni karaa, ama waa la keeni karaa mustaqbalka la xiriira ama ka timaad mid ka mid ah ficillada lagu eedeeyay ee Magaalada, ka dhaafitaannada, dhacdooyinka, ama dhaqanka la xiriira rakibidda, hagaajinta, dayactirka, ama dayactirka dariiqyada waddooyinka magaalada lugeynta. Wareegtada Oggolaanshaha La soo Jeediyay ma bixinayso wax gargaar lacageed ah oo loo fidinayo Dacwoodayaasha. Ma siinaysi wax sheegasho lacageed oo Xubnaha Dacwoodayaasha ay lahaan karaan, ama sheegashooyin kasta oo la xiriira qaybaha xuquuqda lugeynaya ee Magaalada marka laga reebo dariiqyada.

LACAG BIXINTA WAKIILADDA DACWADA

Iyadoo la raacayo ogolaanshaha Maxkamadda, Magaaladu waxay siin doontaa mid kasta oo ka mid ah Wakiillada dacwada \$5,000 iyada oo lagu qaddarinayo shaqadii ay u qabteen iyaga oo matalaya Heshiiska Dacwada.

KHIDMADA, LACAGAHA IYO KHARASHKA QAREENKA EE MACQUULKA AH

Sida ku xusan Xeerka Oggolaanshaha La soo jeediyay, La-Taliyaha Dacwada ayaa ka dalban kara Maxkamadda abaalmarin urooyinka qareennada, Lacagaha, iyo kharashaadka ka yimaada Magaalada si loogu bixiyo shaqadooda kiiska iyo in dib loogu celiyo kharashaadkii ay geliyeen kiiska. Codsiga Qareenada dacwada ee khidmadaha qareennada wuxuu ku salaysnaan doonaa habka "hagitaanka", oo macnaheedu yahay in Qareenada dacwadu ay xisaabin doonaan khidmadooda iyagoo ku dhufanaya waqtiga ay qareennada iyo kalkaaliyeyaasha sharciga ay xafiisyadooda si macquul ah ugu shaqeynayeen kiiska iyagoo ku qiimeynaya saacaddooda macquulka ah

Magaaladu waa inay sidoo kale siisaa La-taliye Dacwada kharashka qareennada ee macquulka ah, lacagta, iyo kharashaadka la socoshada u hoggaansanaanta Magaalada ee Sharciga Oggolaanshaha ee la soo jeediyay sannadihii la soo dhaafay ee uu Go'aanku dhaqan galayay. Khidmadaha dacwoodaha, lacagaha, iyo kharashka kormeerka waxaa lagu xididi doonaa \$70,000 sanadkii shanta sano ee hore ee heshiiska iyo \$60,000 sanadkii wixii intaas kadambeeya.

Dhageysiga, Maxkamaddu waxay tixgelin doontaa wixii diidmo ah ee heshiiska waxayna dhageysan doontaa shaqsiyaadka doonaya inay hadlaan. Haddii aadan rabin in la oggolaado Digniinta Oggolaanshaha, waxaad weydiisan kartaa Maxkamadda inay diiddo oggolaanshaha adoo xareynaya diidmo. Ma weydiisan kartid Maxkamadda inay amarto heshiis kale ama ay bedesho heshiiska; Maxkamaddu waxay

oggolaan kartaa ama diidi kartaa heshiiska. Haddii Maxkamaddu dafirto oggolaanshaha, Magaalada looma baahna doono inay dhisto oo casriyeyso jidadka laga soo raro sida ku xusan Diidmada Oggolaanshaha la soo jeediyey. Taabadalkeed, dacwadu way sii socon doontaa. Haddii taasi ay tahay waxa aad rabto inay dhacdo, waa inaad diidid.
