

Scholarship at IIIT Bhubaneswar

Overview

IIIT Bhubaneswar offers a mix of institute-level awards and assistance (merit, topper awards, tuition-fee waivers and need-based support) alongside students' eligibility for central and state government scholarships (post-matric/SC-ST/OBC, DBT/Ministry schemes, etc.). Financial assistance policies are administered through the Institute's Scholarship Section and the Admissions/Accounts offices.

Major scholarships & awards (typical examples)

- **Tuition Fee Waiver (TFW) & reservation-based concessions** — as per admission category and govt. norms (details in the B.Tech and admissions brochures).
- **Need-based financial assistance** — Discretionary support for students below income thresholds.
- **Ph.D. Fellowships / Assistantships** — stipend and fee concessions for admitted Ph.D. scholars per the Ph.D. brochure and rules.
- **External scholarships** — central/state scholarship schemes (post-matric, SC/ST/OBC scholarships, tribal/DBT portals) — students must apply on the respective government portals and submit proof to the Institute for institute-level processing.

Eligibility

- **Merit awards:** based on programme rank/semester performance as defined in the programme brochure.
- **Need-based aid:** typically required proof of family income (income certificates) and other supporting documents; specific cut-offs (e.g., income < ₹8 lakh) are referenced in admissions/financial assistance notes.
- **Government scholarships:** eligibility (caste, income, hosteller/day-scholar status, state domicile rules) depends on the particular scheme (apply on the respective state/central portal).

How to apply — step-by-step

1. **Identify the scholarship scheme** (Institute award / Ph.D. assistantship / State or Central portal).
2. **Complete the online application on the relevant portal** (for government scholarships) or follow institute-notice instructions for internal awards.
3. **Collect required documents** — fee receipts, admission certificate, caste/income/hostel certificate, bank passbook, AADHAAR, mark sheets.
4. **Submit to IIIT Bhubaneswar:** after online application, email scanned copies from your **IIIT Bhubaneswar e-mail ID** to the Scholarship Section (attach portal application PDF/screenshots and supporting documents). The Institute asks students to email copies after applying online.

5. **Follow up** through the Scholarship Section contact (email / WhatsApp) during office hours if processing is delayed.

Students from other states

- Non-Odisha students apply to **Central/NSP** scholarship schemes (e.g., Central Sector/AICTE/Ministry or their home state post-matric portal) as applicable, or to their state's scholarship portal if eligible. For institute awards and need-based aid, the internal application/upload process is identical — apply online/submit documents and email the Scholarship Section. Always check domicile requirements for state-specific aid.
