Background

Illicit arm trade is the illegal trafficking of small arms and light weapons. In post-conflict areas, some leftover weapons often fall into militias, gangs and criminal groups which can affect the peace as they can use it in any power. Usually leading to violence, instability and leads into conflict. There isn't a date of when it started but we can say it became a crisis in the 1900s during and after conflicts in Africa. Despite international treaties like the Arms Trade Treaty in 2013, the illicit arms trade remains widespread. We see no progress as some countries have corruption and weak border control making enforcement difficult. Recent conflicts in Syria, Libya, Yemen, and the Sahel have worsened the problem as the spread of weapons across entire regions. The regions that have mostly been affected are Africa and the Middle East. We can also see weapons on the black markets undermine peacebuilding by arming insurgents and criminals. Even after peace agreements this Weapons still circulate throughout prevents societies from fully stabilizing. It is still a huge problem since we see weak governance, corruption in post-conflict states, poor disarmament, demobilization and reintegration (DDR programs) There is also a global demand for illegal arms for groups such as terrorism and organized crimes there is also limited resource for border control and tracking of arms. This does not only affect the peace building but civilizations for increasing violence, regional neighbors, and international peacekeepers and humanitarian groups, who operate in unsafe environments.

The main areas affected are Africa(Great Lakes Region, Sahea, Horn of Africa), Middle East (Yemen, Syria, Iraq) , Latin America(Flow of illicit arms from the U.S. to gangs and black market). There have been attempts to solve this problem in 1991, 2001, 2013 which have all been UN attempts to bring this peace. However, there will be regional disarmament programs in Africa and Latin America. Some quick facts can be around 1 billion small arms are in circulation globally; 85% in civilian hands. Up to 50-60% of illicit arms in Africa come from poorly secured government stockpiles. The world bank has stated, Countries affected by illicit arms trade are 42% more likely to relapse into conflict.

UN Involvement

It came to the attention of the UN in the 1990s during the devastating civil wars in West Africa and the Balkans. These conflicts showed the UN how uncontrolled small arms fueled mass atrocities. The following year in 1991, the UN created the Register of Conventional Arms to track state by state weapons transferring. By 1997 the UN general assembly officially recognized the serious threat to peace and security. In 2001, the UN held a Conference on the illicit trade in small arms and light weapons, which produced the UN Programme of Action (PoA) which was the first global framework to try to fight off the crisis. The UN has tried to pass laws starting from 1991 UN established the register of Conventional Arms, this law has been labeled successful. The UN had a different solution in 2001 UN Programme of actions on small arms and light weapons, it has been labeled a limited success. IT doesn't end with those two but the UN also passed an Arms trade treaty(ATT) adopted by the UN general Assembly and it was labeled as successful. There are lots of Organs Involved in Combating Illicit Arms Trade. The

following has been involved; UN Security Council (UNSC), UN General Assembly (UNGA), UN Office for Disarmament Affairs (UNODA), UN Development Programme (UNDP), UN Office on Drugs and Crime(UNODC), and of course we have UN Peacebuilding Commission (PBC). Action on Armed Violence (AOAV) is a specific NGO which helps combat, another example could be Mines Advisory Group (MAG), we also have ITF Enhancing Human Security.

Regional Groups of Member States

African Group: Many countries in Africa see the illicit arms trade as a treaty causing instability, conflict, and underdevelopment across the continent. The African nations have stated that they need stronger cooperation and internal support to control the flow of small arms and light weapons. There is strong support for reduction programs and security sectors, with a focus on addressing problems causing conflict, such as poverty and weak governance.

Asia-Pacific Group: Countries in these regions have prioritized state sovereignty and noninterference but still believe the threat illicit arms pose to regional security and development. There is some caution of support for international arms control agreement, concerns over national security and defense needs. Many states advocate cooperation, they often stress the impotence of illicit arms trade. This is because they are a concern of challenges such as terrorism and transnational crime.

Eastern European Group: Eastern European countries generally take a strong stance on combating illicit arms trade, linking it to regional stability and efforts to prevent organized crime and terrorism. Many support stringent controls and transparency measures, given the legacy of

arms proliferation from post-solveit stockpiles. The push for enhanced international cooperation, intelligence sharing, and stretching of legal frameworks to disrupt tracking networks. They work a lot with the European Union.

Latin America and Caribbean Group (GRULAC): GRULAC view illicit arms as a key factor leading to violence, crime and gang activities mostly in urban centers. Most GRULAC support teamwork efforts as they aim to rescue arms trafficking and improve border security.

. There is a broad backing for international instruments like the ARMS TRADE TREATY (ATT) and regional cooperation mechanisms. Many have chosen to integrate combine arms control with social programs to address violence prevention and community resilience

Western European and Other Group (WEOG): WEOG highly emphasizes the importance of a robust international legal framework. They also want to enforce mechanisms to combat illicit arms trade globally. They advocate for transparent arms tracing and strict export controls, often linking arms trade regulation with human rights and conflicts prevention. WEOG member support by providing technical assistance to post-conflict states and promoting disarmament initiatives through international organizations. They address the need for highlighting challenges such as arms trafficking via digital means and non-state actors.

and trying to prevent violence. This problem gained attention particularly due to the end of the cold war. The international community recognized the importance of constitutional drafts in post-conflict recovery. In recent years the international community has tried to engage in supporting constitution building in conflict affected countries. Many Organizations like UN and International IDEA, have been helping with technical assistance, facilitating inclusive dialogues and tried promoting the incorporation of human rights and democratic principles into their new constitutions. However there are challenges including ensuring national ownership, having the correct balance of external influence and addressing the diverse needs of fragmented societies. Recently multiple countries are undergoing a new constitution building process with the help of varying degrees of international support.

. This highlights the critical role of local actors in shaping constitutional frameworks amidst external assistance. This challenge persists due to several factors such as Complexity of conflicts, weak institutions, external influence and security concerns. The citizens, Government Institutions and international organizations have been affected by this problem. This problem is taking place in Africa (countries like Sudan , Central African republic and Somalia), Asia (Afghanistan's post- Taliban constitution), and in the Middle East(Yemen's prolonged conflict has been delayed). There have been efforts to solve problems like in the 1990s, Post-Cold War era where we saw increased international involvement in constitution-building. 2001 The Bonn Agreement laid the groundwork for Afghanistan's new constitution. 2009 UN Security Council. Resolution 1886 extended support for constitutional reform in Sierra Leone. Most recently in 20023-2025 initiatives focused on integrating local governance into the condition-building process in Yemen and Somalia.

UN Involvement

The UN's involvement in constitution-building gained prominence in the early 1990s. In 1992, the UN defined a peace building as "actions to solidify peace and avoid relapse into conflict", which encompasses supporting the constitution making process in areas of post-conflict. These moments support the shift into recognizing the role of the inclusive governance framework in sustaining peace. The UN's response has been involving Technical assistance, facilitating dialogue, capacity building and monitoring and supporting. The UN's first significant engagement was in the 1990s, in countries like Cambodia and Mozambique. In Cambodia, the UN transitional authority(UNTAC) made the drafting of new constitutional monarchy and democratic governance structures. However as the process faced a challenge, it helped to lay the groundwork for Cambodia's post-conflict recovery. The UN has passed several resolutions mostly emphasizing the importance of inclusive governance and conditional framework. The Security Council Resolutions resolution highlights the need for including political process and constitutional reforms in smaller countries like Sudan and Somalia. General Assembly Resolutions, these have highlighted the role of constitutional assistance in peacebuilding efforts. While both resolutions have provided a normative framework, the success of their implementation varies. There are several NGOs and international organizations, International IDEA, the Carter Center, and The International Crisis Group.

Regional Groups of Member States

African Group:

The African nations support international assistance in constitution-building, but they stress that such process must respect nations' ownerships and not impose "Western Models". Many African nations have experienced conflicts or political transitions often seeking capacity-building, technical expertise and financial support but remain wary of external interference. They are supportive of the involvement of the UN, especially through the partnership of the African Union.

Asia-Pacific Group:

The Asian-Pacific group has more diverse opinions, from strong democracies to fragile post-conflict states. The stance emphasizes state sovereignty and non-interference in domestic affairs. Like in some countries like Afghanistan, Nepal and Myanmar have dealt with major constitutional changes and transitions. They want support in buying inclusive governance but often resisted heavy-handed external involvement.

Eastern European Group:

It's very crucial for eastern European states to implement the rule of law. In addition these states want to include democratic governance and constitutional safeguards. They recognize the importance of constitution building, this is a result of the post-Soviet transitions and benefited from international support themselves.

Latina America and Caribbean Group (GRULAC):

GRULAC countries often value inclusive democracy, social justice, and human rights in the constitution building. Many have a past of their own histories of authoritarianism and

constitutional reform. They see conditions-building as a tool for addressing inequality and protecting marginalized groups, especially indigenous people and women.

Western European and Others Group (WEOG):

WEOG states strongly democracy, rule of law and human rights in conditions-building . They often provide financial support, mediation expertise, and technical advisors to constitution-making processes. They also advocate for gender equality and minority inclusion.

4. How can international support not violate national sovereignty while still being effective?
