Early Childhood Education

Proposed Amendment: Colby is requesting we amend our charter to include early childhood education.

- Early Childhood Cooperative is a new organization in St. Louis. If students enrolled in our school qualify for Free and Reduced Lunch (FRL), 4% we can get per pupil funding for early childhood programming for those students.
- The first step is to amend our charter to include early childhood.

- If we amend our charter, we could formalize a Memorandum of Understanding with an early childhood provider, and they would be the entity providing early childhood education services to 2-3 of our students. This lays the groundwork for us to expand into early childhood programming 2-3 years down the road.
- It has not yet been determined how the children would be selected yet. The children are not guaranteed to move into Atlas. But, we could offer this to families who have an older child at Atlas and have a younger, eligible child.
- Lafayette Prep is taking advantage of this already.

CSD Trust

- Budget: With CSD insurance plan, Atlas could potentially cover the cost of a premium plan for the employee and remain under budget.

- Atlas would be required to make a 3 year commitment to CSD Trust. The reason for this is to protect the financial stability of the trust.
- Are we too small for the trust? No, there are a handful of schools and organizations like Atlas. Small schools want to join the larger organization to spread risk.
- The support staff for the trust and the administrative staff are physically located in STL. Lafayette Prep, Lift for Life, and one other are a part of CSD.

Memorandum of Agreement with Achievement First (Math Curriculum)

- Navigator is a professional development program for our faculty. The cost of the program is \$50,000 to take part in math lessons
- The Opportunity Trust is covering \$35,000, leaving us with \$15,000 cost to enroll with Navigator for the year.
- Kipp is enrolled with Navigator and has had a positive experience
- Tierrus is going to work alongside the coaches from achievement first, and this will help us roll out the curriculum more effectively
