Interpretation and Definitions

Interpretation

The words with capitalized initial letters have meanings defined under the following conditions. These definitions have the same meaning whether they appear in singular or plural.

Definitions

For the purposes of this Privacy Policy:

Account means a unique account created for You to access our Service or parts of our Service.

Affiliate means an entity that controls, is controlled by, or is under common control with a party.

Application refers to **Sard**, the software program provided by **MAB Production**.

Company refers to **MAB Production**.

Country refers to: **Saudi Arabia**

Device means any device that can access the Service, such as a phone, tablet, or computer.

Personal Data is any information that relates to an identified or identifiable individual.

Service refers to the Application.

Service Provider means any third-party company or individual that processes data on behalf of the Company.

Usage Data refers to data collected automatically when using the Service.

You means the individual accessing or using the Service, or the company or legal entity on behalf of which such individual is accessing or using the Service.

Collecting and Using Your Personal Data

Types of Data Collected

Personal Data

While using Our Service, We may ask You to provide certain personally identifiable information that can be used to contact or identify You.

Usage Data

Usage Data is collected automatically when using the Service.

This may include Your Device's IP address, browser type, pages visited, time and date of visit, time spent in the app, unique device identifiers, and diagnostic data.

When accessing the Service through a mobile device, We may collect information regarding device type, operating system, browser type, unique IDs, and mobile network information.

Use of Your Personal Data

The Company may use Personal Data for the following purposes:

- **To provide and maintain the Service**, including usage monitoring.
- **To manage Your Account** and allow access to app features as a registered user.
- **For contract performance**, including purchases made through the Service.

We retain Personal Data only as long as necessary and in accordance with legal requirements. Usage Data may be retained longer for security or improvement purposes.

Your information may be transferred to and stored on servers outside Your region. By using the Service, You consent to this transfer.

The Company ensures adequate protection of Your data in any such transfer.

Delete Your Personal Data

You may request deletion of Your Personal Data by:

- Accessing the account settings inside the Application, or
- Contacting Us directly.

We may retain certain information where legally required.

Disclosure of Your Personal Data

Business Transactions

If the Company is involved in a merger or acquisition, Your Personal Data may be transferred.

Law Enforcement

We may disclose data if required by law or government authorities.

We may disclose Your personal data to:
