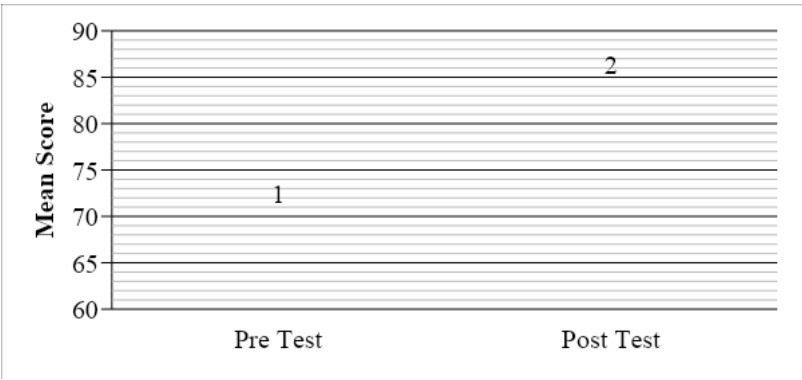


Figure 1. The comparison of results.
