### **What happens if I lose my restoration hearing?**

If your license restoration hearing doesn't go in your favor, you'll need to wait one year before applying again. Alternatively, you can appeal the decision through the Circuit Court. However, it's important to know that the Attorney General's Office often supports the hearing officer's decision, making it essential to present a strong case.
