***By commissioning me, you are agreeing to my Terms of Service.***

## I. General

- Mutual respect.
- If no deadline is requested for the commission, I can take my time to finish it.
- These terms can and will change at any time without warning.
- I have the right to refuse your commission for any reason (I also have the right to not tell you said reason).
- WIPs or Sketches will be sent if you requested, this will be in low quality and with watermark.
- If you want something specific (expression / background / pose / etc.), tell me.
- I make the commissions in the order in which they were placed. You can consult me for your place in my list.
- Be specific with what you want, if you do not say it I cannot draw it.
- If you cancel your commission I don't want to know if you commissioned another artist.
- I will draw in my art-style (semi-realistic) unless otherwise specified.
- If no reference sheet is provided, a charge of **\$100 USD** will be applied to cover character design.

## II. Payments

- Only paypal.
- Payment is full up front, I will not accept intermediate payments (I will show you your commission finished in low quality and with watermark for more confidence).
- I will start to work for your commission when you pay me for it.
- Once initial payment is made, your order will be assigned to the [commission list](#) and I will begin work on it.

## III. Changes

- Color change and small detail changes can be performed free of charge. Large changes require additional payment equal to 100% of the commission price.(If commission is in the sketch phase, large changes are free of charge)
- Further changes cannot be made after final delivery.
- If I don't draw something that was specified, I will change this for free.
- Changes are limited to **3 per order**.

## IV. Refunds

- **No refunds** (think before commissioning me, because I don't refunds).

## V. Copyright/ Usage Policy

- I, the artist, hold every right to the produced drawing, not the commissioner.
- Therefore I'm allowed to use the copyrighted artwork to;
  - Promote myself.
  - Publish books.
  - Display it anywhere.
  - Post it anywhere.

### - The commissioner is allowed to:

-If you break the copyright infringement in any way, every right you had to the drawing will be retracted.-

- Use the copyrighted artwork for personal use only unless agreed otherwise.
- Print the art, and claim the right of their character(s).
- Use the art to promote themselves with proper credit given to the artist.

### - The following is considered Copyright infringement:

- Reproducing/using the copyrighted artwork commercially. (Meaning making money off of it in any way)
- Taking Credit for the creation of the artwork.
- Removing any watermarks/signatures.
- Altering the artwork without my, the artist's, consent.

### **- A Purchase of Commercial rights to the artwork will always be 300% of original price.**

I don't sell NFTs (Non-fungible Token). If you see a piece of my art on an NFT marketplace, This does not have my authorization.

With commercial rights you are allowed to make any sort of merchandise with the artwork.

Use it in books, covers, as Props, change it to your liking and promote your own brand with.

Credit is still required for usage of the artwork, even if altered or edited.
