

Medication Assistance References for Transitions of Care

Extra Help Document – “Extra Help” is a program through Medicare that some patients may be eligible for that assists with the cost of prescription drug plans and copays. This document outlines the process to apply and who would qualify for the “Extra Help”

Links to Copay Cards – The first link takes you to a site with multiple copay cards available (and you do not have to provide patient information to get those)

Patient Assistance Cheat Sheet – this shows the requirements for certain patient assistance programs as well as what financial documents the patient may need (depending on the drug company)

“Bring to Heart Center” Document – this is what the specialty pharmacists are giving to patients to tell them what financial documents to bring with them to include with the patient assistance applications. If you do have a patient that is a Heart Center patient, you can just hand them this document. If they will be applying for patient assistance through another provider, I think you could easily adjust this document to still show them exactly what financial documentation they will have to have.

Jardiance	Boehringer Inhelheim	NO	- No or limited insurance - Income requirements - 250% FPL - No Medicaid accepted

Eliquis	Bristol Myers Squibb	Proof of Income Medicare/caid – OOP	- No insurance or medicare D and you have spent at least 3% of your yearly income on OOP RX expenses in the last year - FPL <250%

Bring to Heart Center

1. “Out of pocket expense report” – have your pharmacy print this out for the past year

2. Proof of Income

Examples: recent tax return, two consecutive pay stubs, social security statement, W2, 1099, pension statement

Bring to Emily (pharmacist) or Haylee (samples and patient assistance technician) on the second floor of The Heart Center.
