Graduate Faculty Status Nomination Form

- Submit this form with the nominee's current vitae or resume.
- Submit to the director for Graduate Studies at gradprograms@ewu.edu.
- The vitae should include the date the terminal degree was earned and EWU employment information, if applicable.
- Newly-hired assistant professors and lecturers are eligible for a probationary 3-year appointment as Primary Graduate Faculty based on holding an earned doctorate or other terminal or professional degree.
- Primary, Secondary, GAC Rep, and Affiliate are valid for 5 years
- Exempt Primary or Secondary status is valid for 2 years for faculty who may not meet the criteria at the time of nomination. (ex. a faculty member requesting primary status does not have two scholarly products in the last 5 years). Faculty may only have one exemption in a 10 year period.

Graduate faculty with Primary status can:

- 1 - Create and revise the graduate curriculum
- 2 - Teach graduate courses
- 3 - Direct graduate research
- 4 - Supervise graduate student field experiences
- 5 - Participate in graduate degree committees as the chair, second or third member

Graduate faculty with Secondary status can:

- 1 - Teach graduate courses
- 2 - Supervise graduate field experiences
- 3 - Participate in graduate degree committees as the second or third member

Graduate Affairs Council Representative (GACR)

- 1 - Participate in graduate degree committees as the third member

Non-EWU Graduate Faculty with Affiliate status can:

- 1 - Supervise graduate field experiences
- 2 - Participate in graduate degree committees as the non-voting fourth member
