F.I.T. Kids After School Program

After School Program Rules & Regulations



F.I.T. Kids is an afterschool program that offers a safe, fun, and nurturing environment for students in Kindergarten through 4th grade. The program will operate daily during the school year from the time students are released from class until 6:00 pm. The daily schedule at F.I.T. Kids includes a snack, homework time, structured physical activity time, and other various activities. Please review the following guidelines:

Payments:

- A one-time \$25 registration fee is due the first week of school.
- The cost of F.I.T. Kids is \$75 per child, per week regardless of the number of days attended by the child. Monthly payments are accepted as well.
- F.I.T Kids is now accepting online payments. You can find where to pay on the school website under the pay fees tab.
- If your account becomes delinquent, you will have 1 week to bring the account current. Failure to do so will result in your child being removed from the program.

Program Hours:

- F.I.T Kids will operate on normal operating school days from the time of dismissal until 6:00pm. We will not operate on holidays, teacher workdays, or on early dismissal days. A calendar will be provided at the beginning of the year with additional days that F.I.T. Kids will be closed.
- Students may be picked up early, but **MUST** be picked up by 6:00pm. **Parents arriving after 6:00pm must pay a fine of \$1 cash per minute. Please be mindful that our staff has additional commitments after 6:00 pm.**
- **Students may be removed from the program due to repeated late pick-ups or non-payment of late fees.**
- If your student misses three consecutive weeks of F.I.T. Kids they will be removed from the program.
- If you have an emergency and will be delayed, please notify Jessie Massie by email at jessie.massie@lcsd.k12.sc.us or you can call the front office at 803-396-3763.

Behavior Expectations:

- We believe all students are capable of behaving properly and following the school-wide behavior guidelines during F.I.T. Kids hours. Therefore, to guarantee your child, and all the students who participate in our program, an excellent learning and social environment, we will enforce our discipline policy.
- Inappropriate behavior may result in your child's suspension or removal from the F.I.T. Kids program. **If you are contacted three times with severe behavior issues your child will be removed from the program.**

Dismissal Procedures:

- If school closes due to inclement weather or any other reason, the program will close also. In this case, the instructions given to your child's homeroom teacher on the inclement weather guidelines will be followed.
- For the protection of your child, only people designated on the registration form will be allowed to pick up your child. If at any time that information needs to be updated, please contact Jessie Massie by email at jessie.massie@lcsd.k12.sc.us
