WEATHER POLICY

Submerge Yourself Aquatics (known hereafter as SYA) will follow the inclement weather policy set in place by the National Lightning Safety Institute. This policy will be to clear the class participants from the swimming pool for 30 minutes following the last sound of thunder or flash of lightning.

MAKE-UP POLICY

In the wake of COVID 19, we are currently offering unlimited makeup lessons with at least 1-hour notice. If you or your child is feeling ill or can't make lessons for any reason, simply text us and wait for your reply. We will reschedule for a different date and time. We will make every attempt to work within the confines of participant's schedules and make up classes if a need arises. If classes are held and you are not in attendance you are not entitled to a refund or make-up. Voicemails left with no contact will not be considered. If lessons are canceled due to inclement weather or other pool closure, we will reschedule the lesson. If at least half of a class period is complete before weather-related or other pool closure occurs, the class may not be rescheduled.

CANCELLATION POLICY

Classes must be paid for in full before services are rendered. Enrollment is based on your purchase plan, be it a single class or multiple classes. If multiple classes are purchased, we will work with you to complete all classes within your schedule. If for some reason classes cannot be completed, we will allow you to transfer classes to another student. No refunds will be given after purchases are made. Credits for cancellations will be handled based on make-up policy as stated above.

ASSOCIATION MEMBER POLICY

Instructors for Submerge Yourself Aquatics are not contracted by the association or community. They are providing a service exclusively to homeowners in that development at the specific request of the individual homeowner. As the homeowner or club member, I authorize coaches of SYA to provide lessons on my behalf.

PHOTO VIDEO AND SOCIAL MEDIA POLICY

Occasionally SYA will take photos and video of students for use on promotional materials like their website or facebook page. In such a case, I consent to interview(s), photography, audio recording, video recording and its/their release, publication, exhibition, or reproduction to be used for news, web casts, promotional purposes, telecasts, advertising, inclusion on websites, or any other purpose by Submerge Yourself Aquatics. MINOR CHILD POLICY

I understand this is not a drop off service. Parents must remain close by and be available by telephone during class time should any questions arise. Parents should be present at the start of class and immediately after class ends for any child under age 14. Instructors will not be required to stay after class ends.

WAIVER/RELEASE OF LIABILITY

I, the enrolled participant, and/or the parent/guardian of the participant agree and understand that swimming is a hazardous activity. I recognize that there are risks inherent in the sport of swimming, including but not limited to, paralyzing injuries and death. The participant hereby agrees to participate in Submerge Yourself Aquatic Swim School and hereby agrees to indemnify and hold harmless Submerge Yourself Aquatics and its coaches and representatives against any liability resulting from any injury that may occur to the participant while participating in the lessons. The participant also agrees to indemnify Submerge Yourself Aquatics and its coaches for any damages including property damage incurred or arising from any claims, demands, actions, or causes of action by the participant. The participant authorizes any representative of the Swim School to have the participant treated in any medical emergency during his/her participation in the lessons. Further, the participant and/or parent/guardian agree to pay all costs associated with medical care and transport for the participant if the need arises.
