Homework: Paper 2 outline

Instructions: Make a copy of this document, send me the link with suggestion permissions, and create an **outline** of what a full-fledged response would look like.

Question: "The most significant cause of human rights violations in global politics is structural violence." Discuss this view.

Please note that I am *not* asking you to write a complete essay. You probably don't have the time, and it's no use if it isn't done within an exam setting. You *can* write an essay in your own spare time – feel free to send it to me in DMs for feedback – but that's not the objective of this assignment. Feel free to use the template below; you may use your own if you'd prefer. I'd also recommend using the body paragraph format [PEEPEL] for an actual paper 2, since it's short enough to remember and

Introduction

Unpacking the prompt - what is the question asking?

Relevant key concepts and political theories

- insert key concept you can list these in one sentence and briefly explain what they are [maximum of 2 **in the intro alone** you will definitely use more than two key concepts, but these two should be the main ones!]

Thesis – overarching structure of your essay [add more claims/counterclaims as needed! I can assure you, you definitely won't get a 4 or 5 with just two points – one point = one paragraph]

Body Paragraphs - copy and paste this template for each paragraph you'll have [same as the thesis. don't expect to pass if you only have one paragraph!]
