JC TRAVEL REWARD PROGRAM

This Reward Program (the "Program") shall be available to JC Authorized Wholesalers ("Applicants") who meet the following qualifications:

1. All JC Authorized Wholesalers worldwide can be qualified for this travel reward;
2. Applicants must have met the number MMPP required and Wholesale Match during the period of June 9 to September 14, 2026, for the first 20 qualifiers;
3. Applicants must have accumulated at least 1,000 new Monthly Maintenance Product Points (MMPP), purchased within the travel reward program period.
4. Applicants must have at least two (2) new direct platinum accounts purchased and registered within the travel reward period to avail the travel reward program.
5. Applicants must have accumulated 50 Qualified Wholesale Match or 5,500 new Qualified Reward Points purchased and registered within the travel reward period to avail the travel reward program.
6. Application is subject to the approval of JC;

Reward Program Mechanics:

1. The Reward program is available from June 9 to September 14, 2026;
2. The program is available to all JC Authorized Wholesalers;
3. Each account is entitled to avail of the program, provided that each account meets the above qualifications;
4. Qualified accounts may avail of the program only once during the period of the program. In case there will be a multiple account qualifiers under the same name, only the first account who have met the requirements and clicked will be qualified;
5. JC shall pay the total amount of the travel reward availed by the qualified authorized wholesaler.
6. To avail this travel reward, JC authorized wholesalers should click the said travel reward once qualified on their JC Portal. There is no absolute availment on travel reward program, unless fully complied within the given qualifications and instructions.
7. For every direct of multiple accounts, Direct accounts and Wholesale match will be credited to the Direct Sponsor, as follows:

*100 Sales Points (SP)is equivalent to one (1) Wholesale Match

*All qualifying reward points is being computed based on the number of earned Wholesale Match during the travel reward period.

*Wholesale Match will be counted as Travel Reward Points once PROMO CODES are purchased and registered within the travel reward period.

8. Any legal documents required for this travel should be complied by the qualifiers, such as VISA, passport and other pertaining documents. Also, the qualifier should comply within the given submission period required by the third party and or any government agencies, otherwise, this travel reward will be forfeited in favor of the company and shall not be converted into cash. All travel flights for this travel reward will depart from Manila.
9. Once an authorized wholesaler is no longer connected with JC on the time of application and actual travel for any violation with JC's company policy, the reward is not transferable, not convertible to cash and will be forfeited in favor of the company.
