You may be wondering who Daisy Gatson Bates is, well she was a black American who was born on November 11, 1914 and saldy passed away on November 4, 1999. When she was three years old her mother sadley passed away by three white men killing her, even though she was only three years old when it happened it still had a massive impact in her life. "When Daisy Bates was three years old her mother was killed by three white men. Although Bates was just a child, her biological mother's death made an emotional and mental imprint on her. The unfortunate death forced Bates to confront racism at an early age and pushed her to dedicate her life to ending racial injustice".(Norwood, 2017, para. 1). Daisy Gatson Bates was only three years old when her biological mother died but it gave her the emotial and mental imprint on her to confront racism at an early age and pushed her to dedicate herself.

She was born in Huttig in Arkanses in 1914 at a foster home and when she was only 15 years old she met her future husband and traveled South. "Daisy Bates was born in Huttig, Arkansas in 1914 and raised in a foster home. When she was fifteen, she met her future husband and began travelling with him throughout the South. The couple settled in Little Rock, Arkansas and started their own newspaper. *The Arkansas Weekly* was one of the only African American newspapers solely dedicated to the Civil Rights Movement. The paper was circulated state wide. Bates not only worked as an editor, but also regularly contributed articles".(Norwood, 2017, para. 2). Daisy Gatson Bates met her future husband and once they stayed at little rock Arkansas they started a newspaper called The Arkansas Weekly which was one of the only African American newspapers dedicated to the Civil Rights Movement.

Daisy Gatson Bates also worked with local civil rights organizations. "Naturally, Bates also worked with local Civil Rights organizations. For many years, she served as the President of

the Arkansas chapter of the National Association for the Advancement of Colored People (NAACP). Her work with the NAACP not only transformed the Civil Rights Movement but it also made Bates a household name".(Norwood, 2017, para. 3). She worked in the Civil Rights organization in helping people.

She ruled a segregated school in 1954. "In 1954, the Supreme Court ruled segregated schools unconstitutional. After the ruling Bates began gathering African American students to enroll at all white schools. Often the white schools refused to let black students attend. Bates used her newspaper to publicize the schools who did follow the federal mandate. Despite the continuous rejection from many Arkansas public schools, she pushed forward".(Norwood, 2017, para. 4). She helps people and children that are African American.
