

Dawn Farm Benefits Summary

(full-time employees)

Pay: Employees are paid in biweekly installments by your choice of check or direct deposit.

Paid Holidays: 7 ½ paid holidays per year (New Year's Day, MLK Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Eve [1/2 day] & Christmas Day)

Health Insurance: Dawn Farm offers health insurance by Priority Health HMO and Dawn Farm pays an average of 84% of the cost. This benefit is as follows:

Employees opting out of health insurance receive a \$1180.40 credit.

Medical Reimbursement: Dawn Farm contributes \$250 to your medical reimbursement account. You can make tax-free contributions of up to \$500 during your first year of service, and \$2750 after one year of service.

Dental: Dawn Farm offers dental insurance by Delta and Dawn Farm pays 63% of the cost. This benefit is as follows:

Retirement 401K Plan: Dawn Farm provides a participating 401K plan. Employees are eligible to participate after one year of employment and are fully vested after five years. Dawn Farm will match 100% of your contributions up to 5% of your salary.

- \$10,000 life insurance policy. Additional coverage available at your own expense.
- \$100/week short term disability insurance. Additional coverage available at your own expense.
- \$500/month long term disability insurance. Additional coverage available at your own expense.

- Health care and dependent care flexible spending accounts available. These allow you to set aside pre-tax dollars for these expenses.

Licensure and certification: Dawn Farm covers employee licensing, testing and certification fees.

We also provide inservices and pay for some external training on an individual basis.
