# Privacy Policy for Agni: School Health Management App

#### Last Updated: October 14, 2024

This Privacy Policy describes how Lattice Innovations Private Limited ("we," "us," or "our") collects, uses, and shares information in connection with your use of the Agni for schools application ("App") for Android devices. We are committed to protecting the privacy and security of student health information.

### 1. Information We Collect

We collect several types of information from and about users of the App, including:

- **Personal Information:** This includes information you provide directly, such as student names, dates of birth, gender, unique identifiers (assigned by the school), and other relevant demographic details necessary for student registration and health management within the school context. We only collect information that is directly relevant to the provision of healthcare services within the school setting.
- **Health Information:** This encompasses vital signs (blood pressure, heart rate, SpO2, blood glucose, height, weight), medical history (as recorded by authorized school personnel), diagnoses, prescriptions, medication dispensing records, and other health-related data entered into the App by authorized personnel. This data is considered sensitive and is treated with the highest level of security.
- **Device Information:** We collect information about the device you use to access the App, such as device model, operating system version, and unique device identifiers. This information is used for troubleshooting, analytics, and to ensure compatibility.

## 2. How We Use Your Information

We use the collected information for the following purposes:

Providing and Improving the App: We use your information to provide the core functionality
of the App, including student registration, health record management, prescription tracking,
reporting, and data synchronization. We use usage data to improve the App's performance,
identify bugs, and add new features.

#### 3. How We Share Your Information

We share information as follows:

- Authorized School Personnel: We share information with authorized school personnel (e.g., nurses, doctors, administrators) who have legitimate access rights within the school system.
   These individuals are bound by confidentiality agreements and HIPAA (or equivalent) regulations as applicable.
- Third-Party Service Providers: We may use third-party service providers to assist us with certain functions, such as data storage, analytics, and security. These providers are contractually obligated to protect the confidentiality of your information and comply with relevant data protection regulations. We do not share personal or health data with these service providers in a manner that would allow them to identify individuals. Aggregated, anonymized data may be shared for analytical purposes.
- **Legal Requirements:** We may disclose information if required by law, court order, or government request.

## 4. Data Security

We implement appropriate technical and organizational measures to protect the security and integrity of your information. These measures include data encryption, access controls, and regular security assessments.

#### 5. Data Retention

We retain your information only for as long as is necessary for the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law.

## 6. Your Choices

While the App's primary function necessitates the collection of student health data, you can manage certain aspects of data use within the school's control. Contact your school administration for information on data access and management options.
