# McCann Physiotherapy — Privacy Policy

*Last updated: November 1st, 2025*

At **McCann Physiotherapy**, we are committed to protecting your privacy and personal data. This Privacy Policy explains how **McCann Physiotherapy** (“Company”, “we”, “us”, or “our”) collects, uses, and protects information you provide through interactions such as when you visit our website, complete a form, access our services, or communicate with us.

We fully comply with the **UK General Data Protection Regulation (UK GDPR)**, the **Data Protection Act 2018**, and applicable clinical confidentiality guidelines set out by the **Health and Care Professions Council (HCPC)** and the **Chartered Society of Physiotherapy (CSP)**.

## 1. Information We Collect

Personal data refers to information that can identify you as an individual. We may collect and process the following categories of personal data:

- **Personal Identification Information:** Name, email address, phone number, date of birth, and address.
- **Emergency Contact Details:** Name and contact information of a nominated person (you are responsible for ensuring they are aware of and accept the terms of this Privacy Policy).
- **Health Information:** Medical history, clinical notes, assessment findings, treatment plans, and other relevant health-related data.
- **Payment Information:** Card details and transaction records (processed securely by third-party payment processors).
- **Usage Data:** Information about your interaction with our website, including IP addresses and cookies (see our Cookie Policy).

We may also collect *special category data*, such as:

- Racial or ethnic origin

- Religious or philosophical beliefs
  - Biometric data
  - Data concerning sex life, gender, or sexual orientation
  - Details of physical or mental health

## 2. How We Collect Your Information

We collect personal data in several ways:

- **Direct Interactions:** When you complete forms, attend appointments, contact us via email, phone, or in person.
  - **Automated Technologies:** Our website may collect technical information about your device and browsing behaviour.
  - **Third Parties:** From GPs, consultants, or other healthcare professionals who refer you to us or share relevant information to support your treatment.

## 3. How We Use Your Information

We will only use your personal data when the law allows and for the purposes for which it was collected. Common uses include:

- **Service Delivery:** To obtain consent and provide safe, effective physiotherapy assessment, treatment, and follow-up care.
  - **Communication:** To send updates, appointment reminders, and service information.
  - **Legitimate Interests:** For service improvement, safety audits, fraud prevention, and business administration.
  - **Legal Obligations:** To meet legal or regulatory requirements.

## 4. Data Sharing

Your personal data may be shared with trusted third parties only when necessary and appropriate:

- **Service Providers:** Such as payment processors, booking software, and IT system providers.
- **Healthcare Providers:** GPs, consultants, or other medical professionals involved in your care, or in an emergency to protect your vital interests.
- **Regulatory or Legal Authorities:** Where required by law or to protect legal rights.
- **Professional Advisers:** Accountants, insurers, or legal representatives.

We ensure that all third parties comply with data protection legislation and maintain strict security of your information.

## 5. Data Security

We employ appropriate technical and organisational measures to protect your data from loss, misuse, or unauthorised access, including:

- Secure storage of records
  - Encryption of sensitive information
  - Password-protected systems and restricted staff access

## 6. Data Retention

Your data is only retained for as long as necessary for the purposes set out in this policy or as required by law.

- **Client Health Records:** Retained for a minimum of **8 years** after the date of last treatment (or until age 25 if treated as a minor), in accordance with CSP and HCPC guidance.
  - **Marketing and Communication Data:** Retained until you withdraw consent.

## 7. Your Rights

Under UK GDPR, you have the following rights regarding your personal data:

- **Access:** Request a copy of your personal data.
- **Rectification:** Request correction of inaccurate or incomplete data.
- **Erase:** Request deletion of your data (where legally permissible).
- **Restriction:** Request limits on how we process your data.
- **Portability:** Request transfer of your data in a commonly used format.
- **Objection:** Object to certain types of processing.
- **Withdraw Consent:** Withdraw consent where data processing relies on it.
