Exercise Overview

Objectives

The **2025 Clark County LEPC TTX** will focus discussion on a hazardous materials release event so that players may evaluate emergency response procedures, identify areas for improvement, and foster collaboration and networking. The TTX will focus on the objectives of:

- Notification of Response/Support Agencies
- Incident Assessment
- Incident Command
- Emergency Public Information
- Medical Facilities

This exercise will begin with a PowerPoint slide setting the stage for players to begin discussion. Play will continue based on a predetermined scenario with a facilitated question and answer time during each module. *Players can request additional information at any time from the Exercise Facilitator* to seek further details or to clarify any misunderstandings. 
Calls come into the 911 Dispatch that there is a wreck involving a placarded semi-truck with a tanker and several passenger vehicles on Westbound I-70 near the overpass of Springfield - Xenia Road. The tanker appears to be leaking and has **placard UN 3362** on it.

Forecast - steady rain approaching overnight.






Impact on Public Information

Schools are in session, and parents are demanding updates on the safety of their children across various social media platforms. The closure of the interstate in both directions has caused major traffic disruptions, stranding commuters and delaying emergency response efforts. Meanwhile, 911 is receiving a surge of calls from concerned citizens across the city who can smell the noxious odors, with some in a state of panic. Media coverage is intensifying, with national outlets once again focusing on Springfield, this time drawing comparisons to East Palestine and fueling rampant rumors. Adding to the chaos, drones are filling the skies as both citizens and media attempt to capture live footage of the unfolding situation.
