You have no criminal record

Financial investment Options in the BG IIP

In order to adhere to the Motivation of Financial Investment Act, you have to offer a direct investment certificate provided by the Bulgarian Ministry of Financing. One of the most safe means to obtain such an investment certification is to purchase a Bulgarian federal government bonds profile. The investment is totally safeguarded and also guaranteed by the Bulgarian federal government.

As a qualified capitalist in BG IIP, you can choose in between 2 financial investment alternatives to participate:

Full Investment Alternative - you will transfer the sum total of BGN 1,000,000 (EUR 511,292) for 5 years. At the end of the 5th year, this quantity is reimbursed to you without accumulated interest.

For the complete investment alternative, you ought to demonstrate individual or family consolidated internet possessions of at the very least EUR 511,292. Most typical properties appropriate for participating in this program are cash money, property, company and financial investment certificates, consisting of bonds as well as stocks.

Financed Investment Alternative - you shall transfer a decreased amount of EUR 170,000. This amount is used to finance a 1,000,000 BGN (EUR 511,292) closed five-year term car loan from a chartered Bulgarian financial institution. The amount of EUR 170,000 is not reimbursed to the financier at the end of the fifth year, because it is used to cover the bank loan expenditures.

For the financed financial investment option, you need to show personal or family members mixed internet possessions worldwide of more than EUR1 million. Most common possessions acceptable for taking part in this program are cash, property, business and also financial investment certificates, including bonds as well as stocks.

On the basis of this investment, you are thought about "unique" by the Bulgarian state, according to the legislation effective, as well as you are granted Irreversible Residential standing for 5 years. After 5 years, you might get

Bulgarian Dual Citizenship.

Lawful Background of the BG IIP

The statutory stipulations of the Bulgarian Capitalist Program for House as well as Citizenship are specified by an amendment in the Immigrants in the Republic of Bulgaria Act (FRBA) law and published by The Bulgarian State Gazette, issue 36 (May 15, 2009).
