The overall length of the article manuscript is minimum of 7 pages and maximum of 14 pages.




Figure 1. Image title

The research result must be clearly concluded in answering research questions. Interpreting the findings must be done by using existing logic and theory. The fact findings found in the research field are integrated with previous studies or existing theories. This must be supported by reliable references. In case, the researcher brings a new theory, the old theory can be confirmed or rejected, or the old theory can be modified.
