### **Privacy Policy for Night Tagging**

  payment information via Meta Quest Store's secure platform, but we do not store your
  financial details.

### 2. How We Use Your Data

Your data is used for the following purposes:

- **To Operate the Game**: To provide, maintain, and improve the Game, including updates and features.
- **In-Game Communication**: To send you important notifications regarding the game, including updates, changes to our services, and other relevant information.

- **Support**: To assist with any technical issues or support requests.
- Marketing and Promotions: If you have opted-in, we may use your data to send promotional emails, offers, or newsletters. You can unsubscribe from marketing communications at any time.
- **Compliance and Security**: To comply with legal obligations, protect against fraud, or detect and prevent any form of unauthorized activity.

### 3. Data Sharing and Disclosure

We may share your information in the following circumstances:

- Third-Party Service Providers: We may employ third-party companies and individuals
  to facilitate our Game, perform related services, or assist us in analyzing how our Game
  is used. These third parties have access to your personal information only to perform
  specific tasks on our behalf and are obligated not to disclose or use it for any other
  purpose.
