2. Provide access to students willing to join the online learning platform.
3. Encourage teachers to maintain quality and consistency in the educational content they produce.

**Revenue Sharing:**

1. Income generated through content monetization and online classes will be shared equally (50% 50%) between the Teacher and Roshiney.
2. The Institution may be offered additional collaboration incentives based on performance and engagement (to be mutually decided in future agreements).

**Term and Termination:**

1. This MoU shall remain effective for a period of one (1) year from the signing date and will automatically renew unless terminated by either party with 30 days written notice.
2. Termination can occur with mutual agreement or breach of agreed responsibilities.

1. Both parties agree to maintain confidentiality regarding all shared information, teacher/student data, and financial details.
