**Superintendent Report -** no discussion

**Principals Report** – no discussion

**Student Services Report** – no discussion

Cabot Mentoring Program – Mark Christensen was present to speak on the program. Express appreciation to the board and school staff. The program feels very supported. Currently have 9 matches. The program is growing. Funding – apply every year to mentor Vermont for a grant. They give professional guidance and training. Received a \$5,000 grant this year and then also fundraise for the program. Started a scholarship program this year. Will be put on the next agenda for further discussion and possible action item.

**Continuous Improvement Plan** (Presentation - Patti Sprague/ Potential Board Action) Patti shared the 3 main goals from the SU strategic plan.

Shared STAR data for Cabot assessments taken.

Academic Achievement Goal – all students show one year of growth in literacy for FY26. Safe and Healthy School Goal – students will be supported with their social/emotional needs hoping to result in at least a 5% increase in daily attendance.

CFP funds that Cabot receives.

A **motion** to approve the CIP by Ellen Cairns and seconded by Alicia Heber. Motion approved.

**CBA Teacher Contract FY26-FY28** (Discussion/Proposed Ratification/Possible Approval) Chris noted some highlights/changes in the new CBA.

A **motion** to approve the CBA by Jason Monaco and seconded by Alicia Heber. Motion approved.

Current enrollment figures – enrolled 28 new students this year, still enrolling.

**Information about lottery spots filled** (Discussion) - of the 12 available, 6 are in use. Of the 6 in use, two are graduating this year.

Current class sizes preK-12 (Discussion) - Chris shared what the State is looking to set for class size minimums under Act 73 and where Cabot class sizes currently fall.

**Act 73** (School Reform bill) / Next steps on future high school options (Discussion) - Task force working on creating 3 maps for the State to look at. Historically when a school does not have a high school, those students have had school choice. There was talk that the legislature is looking to change that and have schools designate up to 3 schools that students can attend. It is not a definite change.

Changes will not take place until 3 years from now. Cabot can decide to continue as is or start talks about other options. Chris spoke on the foundation formula.

**Survey Questions** (Discussion/potential board action) - Chris suggests the survey gets out to families so that the results could come back by mid-October. The board could then look at the results and look at options and see if something needs to be added as a ballot item for the town meeting.

Ellen brought up the point that if Cabot opted to designate up to 3 schools, there is a chance that with the schools designated, some might close due to Act 73.

Went over survey questions and made corrections/changes.

**FY2025 Budget Surplus** (Discussion) - \$330k surplus from FY25. Chris gave the breakdown on what generated the surplus. Last year it was asked to the voters to allow Cabot to take a loan for capital improvements, it has now been suggested to use some of the surplus to do the capital improvement projects vs the loan.

**Playground Update** – the current playground is not what was envisioned and planned for. Possibly use some of the surplus to complete the playground.
