Method

At the end of every quotation, you have to put its reference[s] in footnote style of Jurnal Ilmu Hukum Tambun Bungai. A reference must also be put in the end of every citation that paraphrasing ideas from

someone's article. If citation is taken from a book, it must be like this,¹ and the subsequent citation is like this.² A book with volumes,³ cited in a subsequent note;⁴ book chapter is like this,⁵ journal article is like this,⁶ please note that the footnote reference number is placed after [not before] any punctuation. 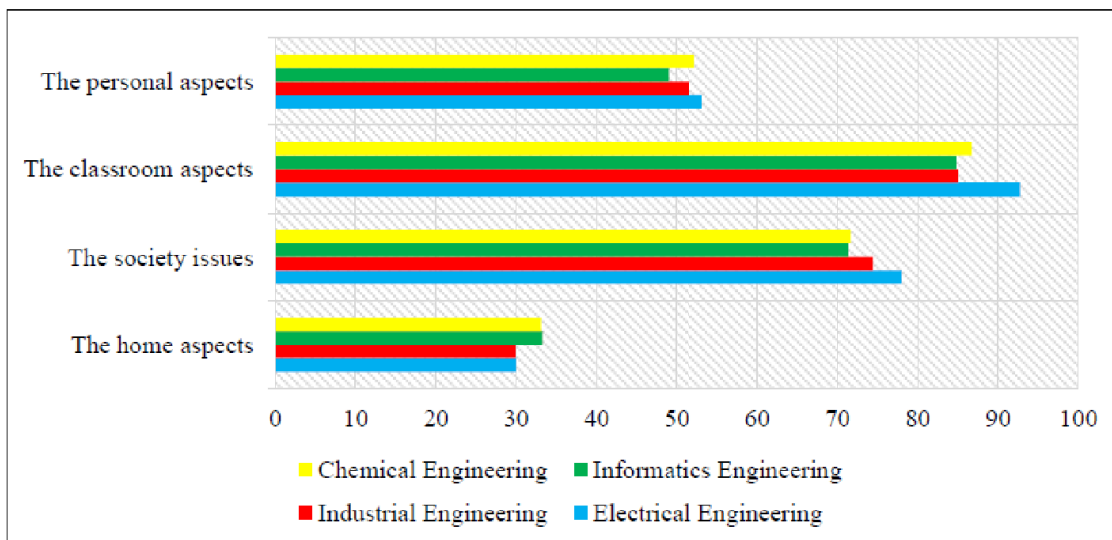


Figure 1. Title of the figure
