ACCEPTING PERSONAL USE **COMMISSIONS**

TERMINOLOGY

- You are the commissioner/client.
- I am Bell. (<https://bsky.app/profile/koboldly.bsky.social>)
- **Commissioning a piece** is when a client hires an artist to create an artwork based on their wants.
- **Requests** - free of charge commissioned artwork
- Artwork/Piece/Product/Commission/WIP/Work/Request is the commissioned artwork.

GENERAL INFORMATION

- First of all, by commissioning me you agree to my T.O.S. as well as acknowledge them in full.
- The T.O.S apply to all work I do. (commissioned artwork, requests, In Progress, sketches, etcetera)

- I have a right to refuse a commission request without stating a written or verbal reason.
- Be polite and mindful of what you say, do not harass the artist or make them uncomfortable, otherwise the commission request will be cancelled or refunded.
- The commission will usually be finished in three weeks(unless another is specified).
 - If it is not completed the commissioner will be notified or refunded.

WORK PROCESS

1. The commissioner sends the artist a commission request in direct messages on Social Media (Ko-fi, Bluesky) or Discord.
2. The artist will either accept or decline the commission request.
3. Upon acceptance the client and the artist exchange ideas, discuss references, mood boards in the same space where the request is. Both sides agree on the pay amount, method (artist prefers Ko-fi or Paypal) and deadlines.
4. The artist sends out a rough sketch for client's approval (for free).
5. Upon approval the artist will finish the commission after they have received the payment.

Note: Unless the T.O.S. gets violated in the process of completing the commission.

6. The client receives the final, completed commission.
7. The artist will send a high quality .png file of the artwork via acceptable means without the watermark only to the commissioner.

Note: Do not hesitate to ask me about the progress on your commission, within reason.

TERMS OF USE

1. Personal use:
 - Uploading the commissioned artwork online with free access

- Printing it for yourself
- The artwork is for yourself or friends
- Non-profitable

2. Commercial use:

- Uploading the commissioned artwork online with paid access
- Using the artwork as a logo, mascot, merchandise or a design
- Profitable

DISTRIBUTION

- You are free to share the commission within the rules of personal use.
- When sharing commissioned artwork, please, credit the artist or share the watermarked version of the piece . (Link or name “BeLL” is also enough)
- You are not allowed to use the commission as merchandise. (shirts, pins, posters, stickers to sell)
- My commissions are not allowed to be used in the development or training of Generative AI (artificial intelligence), and are not allowed to be minted or sold as NFT (Non-Fungible Tokens).
- You cannot claim the artwork as made by you.

PAYMENT AND PRICING

- The price of your commission will be calculated individually.
 - Currently, the price will always be below or equal to 20€
- Payment via Ko-fi or Paypal if preferred.
- Payments are done exclusively in EUR.
- The artist asks for your payment in advance.
 - 50/50 payment is an option, in this case the commissioner will receive a low quality, heavily watermarked version of the commission until the remaining amount is sent to the artist.

REFUNDS

- Contact me, the artist, for a refund.
- If a commissioner wishes for a refund there might be a short wait time.
- Refunds will be deducted a % if WIP has been shown to the client, depending on the state of the commission. Once the flats or shading stage is completed the refund request might be rejected.

EDITS AND CHANGES

- Please, try to be as close as possible to your wishes when making a request in order to reduce the amount of changes.
- First WIP is free for changes.
- Once the sketch is approved there will be a fee for some edits, depending on their difficulty.
- Mistakes made by me, the artist, do not count as changes and can be fixed any time free of charge, except the errors caused by insufficient references.
- You are not allowed to trace, redline, edit or alter the commission or WIP without the artist's permission.
- You are not allowed to remove, blur or cover the watermark unless cropping the image for PERSONAL USE within reason.
(See DISTRIBUTION)

DOs & DONTs

1. I will refuse to work with:
 - Offensive or hateful materials toward any community;
 - Illegal materials (Pedo, zoo);
 - Extreme fetishes. If in doubt-contact me;
 - I will not use AI;
 - Real life firearms and/or military equipment.

2. I prefer drawing:

- Furry;
- Size difference;
- Fantasy creatures, snakes, dragons, dinosaurs, werewolves, faun and so on;
- Medieval, Renaissance, Victorian, Sci-fi settings;
- Dungeons & Dragons, Pathfinder, Starfinder, World of Warcraft, Elder Scrolls and other Tabletop art(characters, monsters, tokens and scenes and comics).

Note: BE SURE TO ASK THE ARTIST FIRST, you're not restricted in themes, these are just preferences!
