## WHAT IS THE SPECIFIC SUB-ISSUE YOU WILL FOCUS ON?

### 1. Why should we care about this issue?

We should care about this issue because of 3 reasons:

- 1. About 15 million Americans are unemployed and need jobs
- 2. America's economy is being hurt by the shipping of jobs overseas
- 3. Unfair/inhumane treatment of workers (very low wages, absurd working hours, etc.)

## 2. Why did other groups/individuals start caring about this issue?

For the same reasons as above. They care about their countries economy. If America's economy goes up, then the other countries economy goes up. But shipping jobs overseas creates less jobs for Americans. The people against outsourcing also believe that labor rights in America should be the same overseas. Rumors have been around stating that many people work for American companies overseas work long hours with no breaks. The workers already receive less pay than America's minimum wage, so people are drawing comparisons to slavery.

## 3. Are there any high-profile individuals in support of your issue?

Mostly Democrats are against outsourcing jobs. There was an act that was recently denied by a mostly Republican senate. Democrats said that the senate was influenced by Romney's opinion. But not all republicans are against outsourcing. Newt Gingrich suprisely, on his campaign trail, mentioned that he supports anti-outsourcing.

### 4. How far back can you trace this particular movement for change?

Outsourcing has been around since the ancient Egyptian and Han Chinese culture. Wherever industrialization has occurred, the concept of outsourcing has been around. Organizations have been using internet for support against outsourcing since the 1990's. Although other movements could have been started before then.

### 5. What major events have occurred in the life of your issue?

206 BC-Present: Like mentioned before outsourcing has started since ancient Han-Chinese culture and has continued to financed countries ever since.

206 BC-Present: Organizations probably have been around since then to stop them.

2010: United States voted yes on American Jobs and Closing Tax Loopholes Act. Congress voted less on tax cuts to hire more jobs in America, when Americans were losing their jobs, before the recession.

2011-2012: Major events include multiple incidents with apple and Samgsung getting caught with labor Issues in the past 2 years.

2012: Congress just denied an act that would help fix some problems with American outsourcing a few months ago.

### 6. What are the other perspectives regarding your issue?

The other main perspective would be the view of the companies themselves. Outsourcing is tempting because it benefits the companies more. Outsourcing means cheaper labor and less restrictions. The work force that this entails is massive. By having cheaper labor, more personnel can be hired. Another reason is the "portfolio effect." By having multiple branches in the company, the company can avoid any major setback. For example, instead of investing everything in one stock, there is less risk that you will lose your money. By investing in different stocks, if one fails, you don't lose all your money.

# 7. What Laws/Supreme Court decisions have been passed regarding your issue? (become VERY familiar with them- for ex. Roe v Wade made Abortion legal)

There was recently in 2005 there was a law passed called the American Jobs and Closing Tax Loopholes Act. they passed the act to create more jobs in america. At the time the national unemployment rate was 9.9% which was pretty high at the time. In 2012 another law, Bring Jobs Home act, was almost passed but the senate which was mostly republican sided to get rid of the law.

## 8. What impact have these legal developments had on your issue?

Many sources state that outsourcing in other countries had an effect on the 2008 recession. The Bring Jobs Home act is recent though and hasn't affected anything socially and economically but could affect the 2012 election.

Here is our mission statement:
