APPENDIX A

The wide variety of public services that are provided directly by Larimer County, or are funded by or through the County, has led to the creation of a variety of categories of appointed officials and managerial employees. Generally, Appointed Employees are Division Directors, Department Directors, Chief Deputies, or other similar officials; however, not all Appointed Employees are management staff. Some Appointed employees serve at the pleasure of the Board of County Commissioners or other elected officials. For some Appointed Employees, the terms and conditions of employment are specified in the Colorado Revised Statutes and for other Appointed Employees, the terms and conditions of employment are decided by the elected official in charge of the County Office in which that particular Appointed Employee is employed. The District Attorney establishes the terms and conditions of employment for appointed staff of the District Attorney's Office.

Appendix A is a complete listing of Larimer County's Appointed Employees. The term "Appointed Official" has been used to describe jobs generally to include: managerial employees at high levels under the jurisdiction of the Board of County Commissioners; professional and managerial employees of the District Attorney's Office; the managerial Deputies and Chief Deputies of the Clerk and Recorder, Treasurer, Assessor and the Sheriff; and certain officials of the Department of Health and Environment.

This matrix shows who has the authority to appoint or separate the Appointed Employee, the administrative reporting structure, who sets salary and compensation level, & the benefit plan eligibility (if any). Once an appointment is made, the appointed status continues indefinitely until revoked with the following exception: under Colorado law, the Veterans Services Officer is appointed for a 2-year term; he/she would need to be re-appointed at the end of the 2-year term in order for the appointed status to continue.
