

DEED OF ACCESSION

KNOW ALL MEN BY THESE PRESENTS:

This Deed of Accession (“Deed”) is made and entered into this _____ day of _____, 20____, by and between:

2. **Rights and Privileges.** Upon signing this Deed by the parties, the Joining Entity shall be entitled to the rights and privileges granted to all (ITB name) members as defined in the MOA.
3. **Obligations and Responsibilities.** The Joining Entity shall fulfill its obligations and responsibilities as set forth in the MOA, including actively participating in the activities and initiatives of the (ITB name), contributing to the development and improvement of TVET programs in the construction sector, and

collaborating with other (ITB name) members towards the achievement of common goals.

4. **Compliance.** The (Joining Entity) shall adhere to the rules, regulations, and policies established by the (ITB name), as well as any amendments or modifications thereto, as duly approved by the (ITB name) members.

5. **Duration.** This Deed shall remain in effect for the same duration as the MOA, unless terminated earlier in accordance with the provisions of the MOA.

6. **Amendments.** Any amendments or modifications to this Deed shall be made in writing and require the mutual agreement of TESDA, (ITB name), and the (Joining Entity).

7. **Dispute Resolution.** Any dispute, claim, controversy, or disagreement arising out of or in connection with this Agreement shall be notified in writing by one Party to the other (s) and the Parties hereto shall endeavor to settle such dispute amicably within thirty (30) calendar days after receipt of the notification.
