  - Appreciation for Collaborative Discussions: The Provost expressed gratitude for the robust and constructive conversations regarding course delivery methods between administrators and faculty through the Faculty Senate.
  - Pastega Awards: A new category has been introduced for the Pastega Awards, specifically aimed at recognizing excellence in teaching among non-tenure track faculty. This category has been funded by the Provost's Office and the





- Foundation, highlighting the institution's commitment to acknowledging outstanding contributions across all faculty roles.
- New Director for Admissions: Joy Brown has been announced as the new Director of Admissions. This appointment signals a renewed focus on enhancing the admissions process and building strong relationships with prospective students.
- Academic Affairs Council/Budgetary Advisory Committee: The Provost discussed the establishment of an Advising Council/Budgetary Committee. This group will focus on developing a transparent mechanism for investing institutional resources, including state allocations. The goal is to support informed decision-making and ensure resource allocation aligns with institutional priorities and strategic goals. The work of the committee which will be faculty and staff will focus solely on academic affairs unlike UBAC which is an advisory to the President and focuses on institutional funding priorities.

### 6. Consideration of New Business

6.1. Faculty Senate extended discussion of President Peter's January 5, 2025 campus-wide email communication.

Senators discussed the critical need for access to and understanding of program budgets, emphasizing how this information is essential for transparency and informed decision-making. They highlighted the importance of ensuring that faculty, staff, and administrators are aware of the financial structures that support their programs and how these budgets impact operations, student success, and institutional priorities.

Additionally, senators explored the possibility of exerting more pressure on the State Legislature to advocate for increased funding for higher education. The discussion acknowledged that state funding for higher education appears to be declining year after year, posing significant challenges for institutions to maintain quality, affordability, and accessibility.

It was noted that the Provost Council also engages in lobbying efforts as part of a consistent and ongoing attempt to increase the state budget allocation for higher education. These efforts reflect a collaborative commitment across institutions to address the funding gap and advocate for better support at the state level.





However, senators acknowledged the complexity of the political and economic landscape, recognizing that despite their collective advocacy, securing more state funding for higher education remains a difficult and persistent challenge.
