****STUDENTS NEED TO BRING A LUNCH & DRINK TO THE MUSEUM.****

Please read this form carefully and be aware that in signing this form you will be waiving and releasing all claims for injuries you or your child might sustain arising from your child's participation in the Field Trip.

Field trips are a privilege, and students may be excluded for reasons relating to attendance, grades, or behavior. Students may be transported in a school-owned or contracted vehicle, and permission is required for a student to participate in such activities. As consideration for Evanston/Skokie School District No. 65 (School District) permitting the Student to participate in the Field Trip, the Student and Parent/Guardian agree to the following:

The Parent/Guardian assumes the full risk of any injuries, including death, damages, or losses which the Student may sustain as a result of participation in any and all activities connected with or associated with the Field Trip.

The Parent/Guardian will indemnify, hold harmless, release and defend the School District, including its Board members, employees, and agents from any and all claims, liabilities, or costs (including attorneys' fees) resulting from injuries, including death, or damages to property, sustained by the Parent/Guardian or the Student and arising out of, connected with, or in any way associated with the Field Trip.

It is the express intent of the Parent/ Guardian that this waiver and release shall bind the Parent's/Guardian's spouse and the members of the Student's and Parent's/Guardian's, family, heirs, assigns, and personal representatives.

In the event of an emergency, the Parent's/Guardian authorizes the School District to secure from any licensed hospital, physician, and/or medical personnel any treatment deemed necessary for the Student's immediate care and agrees that Parent/Guardian will be responsible for payment of any and all medical services rendered. Parent/Guardian assumes responsibility for specifically alerting the School District to any medication that the Student would require during the Field Trip.

If any term, covenant, condition, or provision of this waiver and release is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remainder of the provisions shall remain in full force and effect and shall in no way be affected, impaired, or invalidated.
