TERMS OF REFERENCE

Consultant/Expert to provide training for Family Doctors on ASD Identification and Screening

Position: Consultant/Expert **Type of Contract:** Service Contract

Modus operandi: 10 trainings for family doctors and pediatricians in 10 districts across Moldova

Evaluation type: Mixed (Technical terms, financial terms, interview)

Period of consultancy: October – December 2025

Eligible candidates: Legal entity or natural person which is not registered as an entrepreneur

1. Background and Context

People in Need (PIN) Moldova and SOS Autism are jointly implementing the multi-year project INCLUDE, funded by the Czech Development Agency (CzDA) until December 2027. The action is carried out in close partnership with the Ministry of Health, the Ministry of Labour and Social Protection, the Ministry of Education, and local civil society actors.

The overall goal of the INCLUDE project is to strengthen the inclusion and empowerment of people with autism spectrum disorder (ASD) in Moldova. Within this framework, Output 2.4 aims to build the capacity of family doctors and pediatricians, as specialists of primary medical assistance, to meet the needs of persons with ASD.

Activity 2.4.1 will provide targeted training to about 200 family doctors and pediatricians from 35 District Health Centers to strengthen their ability to identify and screen children for ASD using tools aligned with the Ministry of Health's clinical protocols. As primary healthcare providers, family doctors and pediatricians play a crucial role in early diagnosis and timely referrals to the specialized services.

This activity will include 10 capacity-building workshops, in 10 districts, on:

- Early developmental milestones and behavioral indicators of ASD.
- Administration and interpretation of standardized screening tools (e.g., M-CHAT-R/F for children under 4 years old, ASQ after 4 years old, and other relevant instruments).
- Referral pathways to Early Intervention Centers and Mental Health Community Centers.

By the end of the training, participants will be able to confidently use ASD screening tools and ensure appropriate referrals, thereby improving early detection and intervention outcomes. Tentatively locations of trainings are Balti, Cahul, Chisinau, Comrat, Causeni, Hancesti, Edinet, Orhei, Ungheni, Soroca. Transportation is provided by PIN.

2. Scope of Work

The consultant will:

1. Prepare the training agenda, methodology, and pre/post-training questionnaires.

- 2. Deliver 10 one-day regional training sessions for family doctors and pediatricians. Ten trainings will be on the subject of early diagnosis and timely referrals to specialized services.
- 3. Draft the referral methodology based on the standardized clinical protocol.
- 4. Produce a training report including pre/post-test analysis and recommendations.

5. Selection Process

A. Qualification Criteria

Mandatory qualification criteria - candidates must possess the following mandatory minimum qualifications, which will be evaluated based on the **Pass/Fail** criteria. Failure to meet any qualification criterion will result in immediate disqualification from the bidding process:

- Residency in Medicine (e.g. Pediatrics, Family Medicine, Psychiatry, or related field);
- At least 5 years of experience as a practicing physician, pediatrist, family doctor, psychiatrist or other relevant specialization).
- Certificates and experience in early childhood development, neurodevelopmental disorders, and/or ASD screening.
- At least 2 years of experience delivering professional training to health sector professionals using interactive/practice-based methods.
- Fluent knowledge of Romanian and Russian.

B. Evaluation criteria

The evaluation team will evaluate and award the contract on the basis of the following evaluation criteria:

- 70% Weightage for Technical Proposal
- 30% Weightage for Financial Proposal

Evaluation of Technical Proposal

Evaluation committee will assign points for the best quality of the sample, based on the following evaluation grid:

The technical score is calculated as:

$S = (Points B/Points A) \times 70$

Where:

S = score for technical evaluation

Points A = highest points score from all submitted offers;

Points B = actual points score received from committee.

Evaluation of Financial Proposal

The financial offer should be submitted in MDL and must include all applicable taxes for natural persons (applicant) and VAT 0% for legal entities (applicant).

The financial score is calculated as:

$$S = (Fmin / F) \times 30$$

Where:

- **S** = score for financial evaluation
- **Fmin** = lowest financial offer
- **F** = financial offer under consideration

5. Contract Award

The contract will be awarded to the bid that receives the Highest Combined Score. In the event of an equal number of points, the contract will be awarded to the bid with the lowest price.

6. Application Process

Applications must include:

- CV or Resume and certificates attesting the knowledge and skills in early childhood development, neurodevelopmental disorders, and/or ASD screening.
- Cover letter.
- Two professional references.
- Completed Technical and Financial Offer (Annex 1)
