Introduction

Welcome to StudyRound. This Privacy Policy is intended to inform you about how we collect, use, share, and protect your personal information when you use our educational application ("App").

1. Information We Collect

1.1 Personal Information

We may share your personal information with third parties in the following circumstances:

- With your consent or as otherwise permitted or required by applicable law.
