PE and Sport Premium Grant: Impact, Opportunities, and Sustainability Report

Overview

This document reports on how a school has allocated its PE and sport premium funding to enhance physical education, sport participation, and inclusivity, particularly for pupils with SEND, girls, and disadvantaged pupils. It evaluates the positive impacts on staff confidence, pupil engagement, attainment, and sustainability of improvements, including swimming and water safety outcomes for Year 6 pupils.

Main Points

- Funding targeted inclusive PE and sport opportunities for pupils with SEND and long-term medical conditions through staff training, extra-curricular support, and top-up swimming lessons.
- Specific spending increased girls' participation in PE and extra-curricular sport via specialist activities and competition opportunities.
- Disadvantaged pupils benefited from subsidised sports and physical activity clubs to improve access.
- Positive impacts recorded on staff confidence, knowledge, and skills in teaching PE and sport.
- Increased pupil engagement in regular physical activity and sport across the school.
- Raised profile of PE and sport contributed to whole school improvement.
- Broader and more equal experiences of various sports and physical activities were offered to all pupils.
- Participation in competitive sports increased.
- Improvements noted in pupil attainment in PE, physical activity levels, extra-curricular participation, staff training completion, and swimming proficiency.

- Year 6 cohort achieved 100% competency in swimming 25 metres, use of multiple strokes, and safe self-rescue skills.
- Spending has supported sustainable improvements in PE and sport provision.
