## V. Entry fee for the Competition:

### 1. The amount of the entry fee:

- a. Members of the Kraków Mountaineering Club according to age categories:
  - Younger Junior/Younger Junior Women (born in 2008 2007): PLN 50 per person,
  - Junior/Junior Woman (born in 2006 2005): PLN 50 per person,
  - Senior/Senior Woman (born between 2004 1976): PLN 150 per person,
  - Nestor/Nestorian (born 1975 and earlier): PLN 150 per person.
- **b.** Other persons according to age categories:
  - Younger Junior/Junior Woman (born 2008 2007): PLN 150 per person,
  - Junior/Junior Woman (born in 2006 2005): PLN 150 per person,
  - Senior/Senior Woman (born between 2004 1976): PLN 200 per person,
  - Nestor/Nestorian (born 1975 and earlier): PLN 200 per person.

### 2. Deadline for payment of entry fee:

- **a.** The entry fee must be paid within **24 hours** from submission of the application.
- **b.** The Organizer may remove a competitor from the entry list if he/she fails to pay the entry fee by the date mentioned in item. V.2.a.
- c. The date of payment of the entry fee determines priority of placement on the start list.

## 3. Method of payment:

- b. It is not possible to pay the entry fee in the Competition Office or to pay the entry fee in cash.

## X. The Competition route:

- 1. Basic route for age categories: Senior/Senior Woman and Nestor/Nestorian Appendix No. 1:
  - a) Route description:
    - From the start near the Schronisko Morskie Oko along the yellow trail towards Szpiglasowa Przełęcz. After crossing Szpiglasowa Przełęcz with the yellow trail in the direction of the Wielki Staw Polski, and then with the blue trail to the split of trails to Kozi Wierch. Then with the black trail about 750 m towards Kozi Wierch and return to the blue trail to the split of trails towards Dolinka Pusta. Then follow the yellow trail to Dolinka Pusta to Kozia Przełęcz and then follow the yellow trail from Kozia Przełęcz to Kozia Dolinka until you reach the blue trail near Zmarzły Staw, and then follow the blue trail to Przełęcz Zawrat, then along the blue trail to the finish line on the surface of the Przedni Staw Polski near the Schronisko PTTK w Dolinie Pięciu Stawów Polskich.

The order of the route according to the checkpoints on Appendix 1: 1 (START), 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 (META).

- **b)** Parameters of the route: length: about 14.49 km, elevation: about 1865 m.
- 2. Basic route for age categories: Younger Junior Male / Female and Junior Male/Junior Female Appendix No. 1:
  - a) Route description:
    - From the start near the Schronisko Morskie Oko along the yellow trail towards Szpiglasowa Przełęcz. After crossing Szpiglasowa Przełęcz with the yellow trail in the direction of Wielki Staw Polski, and then with the blue trail to the split of trails to Kozi Wierch. Then by the black trail about 750 m towards Kozi Wierch and return to the blue trail to the splitting of the blue and yellow trails. Then about 500 m with the blue trail towards the Przełęcz Zawrat Pass and return along the blue trail to the Main Finish on the surface of the Przedni Staw Polski near the Schronisko PTTK w Dolinie Pięciu Stawów Polskich.

Sequence of the route according to the checkpoints on Appendix 1: 1 (START), 2, 3, 4, 5, 6, 6a, 12, 13 (META).

- b) Parameters of the route: length: about 10.60 km, elevation: about 1150 m.
- 3. Alternative route for age categories: Senior/Senior Woman and Nestor/Nestorian Appendix No.2:
  - a) Route description:
    - From the Start at Wodogrzmoty Mickiewicza near the so-called "benches", along the green trail towards the Schronisko PTTK w Dolinie Pięciu Stawów Polskich to the beginning of the black trail in front of Siklawa and then along the black trail with the so-called winter bypass to the Schronisko PTTK w Dolinie Pięciu Stawów Polskich. Then with the blue trail to the split of trails to Kozi Wierch continuing about 750 m with the black trail towards Kozi Wierch and returning to the blue trail until the blue and yellow trails split. Then along the yellow trail to Pusta Dolinka to Kozia Przełęcz and further

to Kozia Dolinka, up to the blue trail near Zmarzły Staw, continuing along the blue trail to Przełęcz Zawrat. Then along the blue trail to the Finish Line on the surface of the Przedni Staw Polski near the Schronisko PTTK w Dolinie Pięciu Stawów Polskich.

The order of the route according to the control points on Appendix 2: 1 (START), 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 (META).

- **b)** Parameters of the route: length: about 13.68 km, elevation: about 1725 m.
- 4. Alternative route for age categories: Younger Junior Male / Female and Junior Male/Junior Female Appendix No. 2:
  - a) Route description:
    - From the start at Wodogrzmoty Mickiewicza near the so-called "benches", along the green trail towards the Schronisko PTTK w Dolinie Pięciu Stawów Polskich to the beginning of the black trail in front of Siklawa and then along the black trail with the so-called winter bypass to the Schronisko PTTK w Dolinie Pięciu Stawów Polskich. Then follow the blue trail to the split of trails to Kozi Wierch continuing about 750 m with the black trail towards Kozi Wierch and return to the blue trail until the blue and yellow trails split. Then about 500 m with the blue trail towards the Przełęcz Zawrat and return along the blue trail to the finish line on the surface of the Przedni Staw Polski near the Schronisko PTTK w Dolinie Pięciu Stawów Polskich.

Sequence of the route according to the checkpoints on Appendix 2: 1 (START), 2, 3, 4, 5, 5a, 11, 12 (META).

- **b)** Parameters of the route: length: about 9.79 km, elevation: about 1000 m.
- 5. Backup route for age categories: Senior/Senior Woman and Nestor/Nestorian Appendix No. 3:
  - a) Route description:
    - From the Start near the Schronisko PTTK Murowaniec along the yellow trail to Kasprowy Wierch (around the summit) and down the ski slope on Hala Goryczkowa to the area of the lower station of the chairlift to Goryczkowa Rówień Niżna. Then follow the ski trail to Kasprowy Wierch (near the summit), return along the ski slope on Hala Goryczkowa in the vicinity of the lower station of the chairlift to Goryczkowa Rówień Niżna and again along the ski trail to Kasprowy Wierch (near the summit), and then descend along the ski slope on Hala Gąsienicowa to the Finish near the Schronisko PTTK Murowaniec.

The order of the route according to the checkpoints on Appendix 3: 1 (START), 2, 3, 4, 5, 6, 7, 8, 9, 10 (META).

- b) Parameters of the route: length: about 13.08 km, elevation: about 1845 m.
- **6.** Backup route for age categories: Younger Junior Male / Female and Junior Male/Junior Female Appendix No. 3:
  - a) Route description:
    - From the Start near the Schronisko PTTK Murowaniec along the yellow trail to Kasprowy Wierch (around the summit) and down the ski slope on the Hala Goryczkowa to the area of the lower station of the chairlift to Goryczkowa Rówień Niżna. Then along the ski trail to Kasprowy Wierch (near the summit) and down the ski slope on Hala Gąsienicowa to the Finish near the Schronisko PTTK Murowaniec.

The order of the route according to the checkpoints on Appendix 3: 1 (START), 2, 3, 4, 5, 6, 10 (META).

**b)** Parameters of the route: length: about 8.87 km, elevation: about 1165 m.

### XI. Conditions for participation in the competition:

- 1. Eligibility: Participation in the competition is strictly limited to individuals who possess:
  - **a)** A valid medical certificate confirming that their health condition permits safe participation in ski mountaineering competitions;
  - b) Accident insurance coverage specific to ski mountaineering competitions;
  - c) A valid license from the Polish Mountaineering Association in the discipline of ski mountaineering (requirement applicable only to Polish competitors participating in the PZA Polish Cup).
- **2. Declarations:** By registering for the competition, participants declare that they possess the medical certificate, insurance, and license referred to in point XI.1.
- **3. Document Submission:** The Organizer may require participants to provide the original or a copy of the medical certificate or insurance mentioned in point XI.1, either before the competition or within 14 days after its conclusion. Notification will be sent to the participant via email to the address provided during registration. Failure to submit the required documents within 14 days from the date of the

notification email may result in disqualification, following prior notification to the PZA Ski Mountaineering Commission.

- 4. Equipment Compliance: Only competitors equipped in accordance with Chapter III of the Ski Mountaineering Competition Regulations of the PZA Ski Mountaineering Commission will be permitted to start. Competitors must have the mandatory basic equipment and any additional required equipment specified no later than at the main briefing. By registering, participants declare that they are aware of the equipment requirements and are proficient in using the specified equipment (including skis, crampons, avalanche gear).
- **5. Minors' Participation:** For underage participants, a written consent from parents or legal guardians is required. This consent must be submitted to the Competition Office no later than at the time of collecting the starting package and should conform to the template provided on the Organizer's website and at the Competition Office.
- **6.** Lack of Consent: Failure to provide the consent mentioned in point XI.5 will result in the participant not being allowed to start the competition.
- **7. Starting Package Collection:** Participants are required to collect their starting packages in person. Collection by another person is possible only upon presentation of a written authorization and an identity document.
- **8. False Documentation:** Submission of any false documents or providing false information may result in the participant's disqualification. The participant may also be banned from participating in the next five editions of the Jan Strzelecki Memorial.

## XII. Competition Format

- **1. Regulations:** The competition shall be conducted in accordance with:
  - a) These Rules;
  - b) The Ski Mountaineering Competition Regulations of the PZA Ski Mountaineering Commission (Regulamin zawodów w narciarstwie wysokogórskim Komisji Narciarstwa Wysokogórskiego PZA)
  - c) The 2024/25 Polish Cup Regulations in Ski Mountaineering of the PZA Ski Mountaineering Commission (Regulamin Pucharu Polski 2024/25 w narciarstwie wysokogórskim Komisji Narciarstwa Wysokogórskiego PZA)
- 2. Individual Participation: Competitors shall compete individually.

### XIII. Start Procedure and Timekeeping

- 1. **Common Start:** The start is common for all competitors in each category.
- 2. Assigned Numbers: Each competitor will be assigned a starting number.
- 3. **Continuous Timing:** Time measurement is carried out continuously along the entire route of the competition from the start to the finish line.

## XIV. Calculation of Competitor Rankings

1. **Determination of Winner:** The competition is won by the competitor with the shortest time, which is the sum of the time on the route and any penalties.

### XV. Competitor Classifications within the Memorial

- 1. Jan Strzelecki Memorial: OPEN in the women's and men's categories (without age division).
- 2. **Krakow Mountaineering Club:** According to the Classification Regulations of the Krakow Mountaineering Club members.
- 3. **Jerzy "Jorguś" Zachorowski Award:** According to the Regulations for the Jerzy "Jorguś" Zachorowski Award classification.
- 4. **Mountain Rescuers:** OPEN category, according to the Mountain Rescuers Classification Regulations.
- 5. **PZA Polish Cup:** According to the 2024/25 PZA Polish Cup Regulations.

### XVI. Rules Pertaining to the Competition Location

- 1. **Venue:** The competition shall take place within the Tatra National Park (hereinafter: TPN).
- 2. **Compliance with TPN Rules:** Competitors are obliged to adhere to the regulations in force within the TPN, available at:

o https://tpn.pl/zwiedzaj/narciarstwo

In particular, competitors must observe the following prohibitions:

- o Leaving marked trails;
- o Littering;
- o Creating excessive noise;
- o Disturbing wildlife.
- 3. **Use of Reusable Containers:** During the competition, competitors are required to use only reusable containers for beverages and food.
- 4. **Courtesy to Other Visitors:** Participants must conduct themselves in a manner that does not impede other individuals (particularly tourists) visiting the TPN.

### XVII. Protests


- 1. **Submission of Protests:** Protests must be submitted in writing to the Chairperson of the Jury through the Competition Office within 15 minutes following the announcement of the unofficial results.
- 2. **Publication of Unofficial Results:** The unofficial results will be posted at the Competition Office or at a location specified in these Rules.
- 3. Contents of the Protest: A protest should include:
  - o The full name of the complainant;
  - o The complainant's telephone number and email address;
  - o The number or name of the competitor concerned;
  - A detailed description of the protest;
  - The specific points of the Rules that have been violated.
- 4. **Protest Fee:** The Competition Jury may require a protest fee of 100 PLN in cash, which will be refunded if the protest is upheld.
- 5. Composition of the Jury for the Memorial and PZA Polish Cup:
  - o Chairperson: Chief Referee Magdalena Syrek;
  - o Jury Member: Competition Director Jacek Grabarz;
  - o Jury Member: Route Manager Piotr Krygowski;
  - o Jury Member: PZA Ski Mountaineering Commission Delegate Tomasz Tywonek.
- 6. **Decision-Making Process:** The Jury's decisions are made by a simple majority vote with all members present.

### **XVIII. Additional Provisions**


- 1. **Acceptance of Regulations:** Submission of an application to participate in the competition constitutes acceptance of these Regulations and an obligation by the competitor to comply with them.
- 2. Organizer's Right to Deny Participation: The Organizer reserves the right to deny participation to any competitor who lacks the required equipment, a valid medical certificate, personal accident insurance, appears to be under the influence of alcohol, intoxicants, or psychoactive substances, or whose health condition prevents safe participation in the competition.
- 3. **Participant's Declaration:** By registering for the competition, the participant declares that their health condition permits safe participation in the Memorial, and that they will not participate under the influence of alcohol, intoxicants, or psychoactive substances that could adversely affect their judgment and assessment of risks associated with ski mountaineering competitions.
- 4. Awareness of High-Mountain Terrain: The participant acknowledges that the Memorial route traverses high-mountain terrain and affirms familiarity with, and commitment to adhere to, safe movement practices in such environments, as well as the Organizer's safety guidelines. Competitors are obligated to independently assess mountain conditions, exercise caution, match their skills to the prevailing course conditions, and respond appropriately to changes in weather or course conditions. The competition may be canceled in the event of exceptionally adverse weather conditions, avalanche risk, or other causes beyond the Organizer's control.
- 5. **Compliance with Organizational and Safety Rules:** Participants are required to adhere to the organizational and safety rules established by the Organizer, as well as general safety principles.
- 6. **Limitation of Liability:** To the extent permitted by applicable law, the Organizer and its associates are liable only for actual damages directly caused by their actions or omissions; all other liability is excluded.

- 7. Consent to Use of Likeness: Participants consent to the free use and dissemination of their image, voice, and statements recorded in photographs, films, recordings, and other materials made during the competition by the Organizer and its associates. The use of participants' likenesses may occur particularly in informational materials related to the Memorial, its organization, and promotion, issued by the Organizer or its sponsors, as well as in materials promoting the Memorial, the Organizer, and ski mountaineering in the media (including press, radio, television, internet portals, social media, graphic materials, presentations at festivals), also in future years. This consent is not limited in time or territory.
- 8. **Withdrawal from the start.** Persons who withdraw from the start cannot request a refund of the entry fee
- 9. **Swapping places on the starting list.** The Organizer allows for the possibility of substituting participants only in the case of the registration limit being reached.
- 10. **Cancellation of the Competition.** If the competition does not take place, the Organizer will refund the entry fee.
- 11. The final interpretation of the Rules belongs to the Competition Jury.
- 12. - 13. The Organizer reserves the right to change the Rules, especially due to currently applicable laws (including those introduced by PZA or ISMF) or prevailing weather conditions and route conditions.
- 14. Announcement of changes to the Rules will be made on the website: <a href="https://strzelecki.kw.krakow.pl/edycja-2025/Regulaminy.ipotrzebne-dokumenty/">https://strzelecki.kw.krakow.pl/edycja-2025/Regulaminy.ipotrzebne-dokumenty/</a>.
- 15. **Witdrawal during competition.** Each participant may withdraw from further participation in the competition on their own initiative or be removed from the route by the Organizer. Withdrawal or removal from the route should take place at a control point, except in extraordinary circumstances. The Competition Jury decides on extraordinary circumstances. A participant withdrawing from the competition on their own initiative is obliged to inform the nearest judge.
- 16. **Fair play.** All participants are obliged to assist a person in danger. In case of injury or fainting of a participant, other participants nearby should notify the Organizer. The Jury will take into account the time spent providing assistance.
- 17. As far as financial and logistical possibilities allow, the Organizer will provide participants with a regenerative meal the decision will be announced at the main competitors' briefing.
- 18. Participants, as part of the entry fee, have paid for entry to the Tatra National Park.

- 20. In case of discrepancies between the regulations mentioned in points XII.1.b. and XII.1.c. and these Rules, these Rules shall prevail.
- 21. This version of the Rules is effective from February 5, 2025.
- 22. Competition Regulations have been drawn up in two language versions: Polish and English. In case of any discrepancies between the Polish and English language version, the Polish language version shall prevail.
