This Week's Issue Is:

The current threats against our Democracy and the Constitution by MAGA supporters who lie about the Jan 6th Insurrection and the high threat level of political violence incited by MAGA leadership explicitly and through hidden messaging.

What We Want Cliff and Lori to Do:

- Denounce the Jan 6th insurrection and call for the prosecution of all who
 participated in the attempted murder of the Vice President, Speaker of the
 House, and the coup to block the peaceful transfer of power.
- Fund the FBI and the DOJ so they have the resources to bring these criminals to trial.
- Denounce calls for violence by GOP leaders.

Optional Talking Points, and What You Need To Know:

- Democracy makes abortion rights, climate solutions, healthcare, unions, and social safety net programs possible. Fascism silences the populace or imprisons them
- Rep. Bentz voted to disqualify the PA electors when the House re-convened AFTER the insurrection. In his first vote as a member of the House, Bentz became a member of the "sedition caucus."
- By supporting the insurrection and attacking the functioning of government Rep Bentz and Rep DeRemer are attacking Democracy and enabling Fascism.
- Rep Chavez-DeRemer supports the former President and she voted for Speaker Mike Johnson, both of whom acted in the insurrection. Speaker Johnson led the sedition caucus!
- In a televised candidate interview with the Oregonian in 2022, Rep Chavez-DeRemer implied that insurrections were peaceful protestors and she

- expressed her concern for their legal rights. Insurrectionists were prosecuted for their actions in invading the Capitol, assaulting law enforcement officers, and disrupting the electoral process.
- The FBI lacks the manpower to investigate and prosecute 60% of the insurrectionists due to a lack of funding. Both Rep Bentz and Rep DeRemer voted in the MAGA Debt Default Bill to cut funding to the FBI by 22% while saying they support law enforcement.
- Rep Chavez-DeRemer perpetuates the "Big Lie" by refusing to say whether the 2020 election was valid.
- Trump quotes Hitler and makes calls for political violence in general and specifically at targets, such as Manhattan DA Alvin Bragg and the judge who will preside over the case, Judge Juan Merchan. Rep Bentz and Rep Chavez-DeRemer refuse to denounce this despite numerous constituent requests.

Dear Rep. Bentz / Chavez-DeRemer,

Please denounce the Insurrectionists who sought to overturn the 2020 election illegally and block the peaceful transfer of power. Denounce the calls for political violence. Fund the FBI and the DOJ so they have the resources to protect us.
