About

The United Kingdom's Online Safety Bill (OSB) puts the future of Wikipedia and other public interest projects at risk.

The OSB addresses important safety issues to protect children and adults online. However, in its current state, the Bill unduly threatens the survival and welfare of projects that prioritise the public interest over profits. There is a short window of time to influence UK government leaders to exempt Wikipedia and other public interest sites from the legislation, before it becomes law.

On 30 June, the Wikimedia Foundation, Wikimedia UK, and fellow public interest projects committed to a better internet for all published an open letter to the UK Government and



Parliament, requesting an exemption for public interest projects in the Online Safety Bill. You can learn more in this [blog post](#).


