

Micro Kinetics Engineering Privacy Notice

Micro Kinetics Engineering ("we", "us" and "our") respect your privacy. This privacy notice ("App Privacy Notice") describes our privacy practices regarding the collection, use, and disclosure of your personal information through all of our mobile applications (our "app" or "apps").

1. What We Collect.

Information you provide:

Any information that you provide to any Micro Kinetics Engineering app will only be used on your phone by the app to provide you the services advertised by the app and will not be sent to, or retained by Micro Kinetics Engineering. We will not require you to register your apps with us.

Information your device provides:

The types of information that may be collected by our apps, depending on the app you purchase, may include:

- Device details such as OS, device ID and device type.
- Location of your device, but only for features like mapping or navigation.
- Data entered by you that is stored is only stored on your device for permanent storage as required by the app.
- Battery levels, network connection status, WIFI status, on/off device status.
- Device setup information that is related to the apps functionality, such as Airplane Mode setting.

Access to some of the above information (such as device location) may be restricted by your mobile device's operating system, and your consent will be requested as required by your OS version before any of our apps would access the information on your device. It is your choice whether you wish to provide consent; however, if you do not provide consent, some functionality of the app may be restricted.

2. How We Share Your Information.

Third party service providers

We do not sell, rent or share information that identifies you personally like your name, email address, phone number, or address.

Third party service provider terms

Some of our third party service providers may have additional terms and choices that apply to your information which we are required to make available to you as follows:

Google Maps: If the app uses Google's Maps API, it is governed by Google's Privacy Policy available here: <http://www.google.com/policies/privacy>. Certain Maps API(s) store and access cookies and other information on end user's devices.

3. Security.

No app or Internet transmission can ever be guaranteed 100% secure. Where personal data collected is stored on your device, security is through your device's own secure storage facilities. You should also take care to protect the secrecy of your account user name and password and to protect the personal information that is stored on your device.

4. Data Retention.

We retain no information from your device such as phone number, etc., for the time you have a Micro Kinetics Engineering app installed on your device. If you uninstall our app, the personal data that the app stores on your behalf is deleted. If the app supports a migration feature, you may have the option of exporting your data in case you ever decide to re-install the app and/or want to import that dataset to another device.

5. Use of Services by Minors.

We comply with the Children's Online Privacy Protection Act of the United States and similar laws around the world where applicable our products and services. We do not knowingly collect personal information from children without proper parental consent. If you believe that we may have improperly collected personal information from someone under the applicable age of consent in your country, please let us know using the methods described in the [Contact Us section](#) and we will take appropriate measures to investigate and address the issue promptly.

6. Notice to California Residents.

Section 1798.83 of the California Civil Code requires us to tell you that we do not share your personal information with third parties for their direct marketing purposes.

If we make any material changes to the way we collect and use your personal information, then we will also take other reasonable measures to inform you. Where required by law, we will seek your affirmative consent to such material changes.

Except where prohibited by law, your continued use of Micro Kinetics Engineering apps following such changes will confirm that you have read and understand the updated Mobile App Privacy Notice.

We will not send marketing-related messages to you, either in the app or by other means.
