### V. On-Site Storage

- Students must store personal internet-enabled devices in designated locations, such as lockers or secured device pouches.
- Students are responsible for the safekeeping of personal devices; the district is not liable for loss or damage.

I didn't.

I was standing there now, with no phone, backpack with me, seeing my girlfriend asked questions on why we kept showing up late since the beginning of school, and security being petty, as I said.

The security lady who caught us kept saying, "My machine never lies."

So I said, "If you're machine never lies, you would've caught other students and me with our phones the second day. Did you though?"

No more they spoke, I can't tell because I shut them up or they just didn't want to answer.

Knowing the adults, probably the second, since they don't want to get a bad rep.

I know it's because I put them down.

That was the end for me, for now.

With my girlfriend.

The attendance lady kept asking my girlfriend why we kept showing up late to school and she was pressuring her to really tell her.

It's kind of her thing, she's always nosey really.

Like REALLY nosey, I don't give her the satisfaction.

Until she said why, see my pinned TikTok on what she said to her.

She called me over and eventually asked where I live to sum it up and told me to go to my class but sent me to guidance to fix my schedule cause they kept messing it up. Like always, never in order.

Now, at the time, when I left, I didn't know this but she told my girlfriend to watch who she socializes with because it'll "give her a bad rep."

From what my girlfriend said, she told me to go because she wanted to talk bad about me.

This isn't the first problem I've had with that lady.

In Freshman year, I defended my girlfriend from her and told me to go. She kicked me out this time because she didn't want me defending her. She knew I would.

She ASSUMED I would.

You'll see why I said that later, again.

My girlfriend came with me to also do something but then after a while, she left and I stayed, I didn't want to leave.

Then that's where the, "she wanted to talk shit about you" came from. And the "bad rep."

Until 5th period I came back to my classes but I had several arguments with her before that.

The second time, or the big one, she asked what was wrong, as if we didn't just argue about something stupid. On both of our ends.

I said "I really don't know, I ask myself the same thing and I just can't figure it out. I really can't. I wonder."

She starts acting like she cares.

And eventually I start telling her that if she has a problem with me, she can insult me in front of my face.

She said she was always professional but I didn't believe it because she tried to fabricate the story.

So here's her thing.

She said the thing I said, my girlfriend only wanted me to "hear what I wanted to hear" and I never told her that my girlfriend said anything about what she said apart from insulting me so here's what she said, or what I remember.

But then I complained about my laptop because why did OTHERS have them?


They tried to bribe, make a deal, or just sound smart because then they just said to tell the Principal that I saw others so I could have my computer back.

### III. Exceptions for Educational and Essential Use

Student use of internet-enabled devices may be permitted:

Student use of personal internet-enabled devices may be permitted under the following circumstances:

- 1. For educational purposes, when authorized by a teacher or administrator.
- 2. For health-related needs, such as the use of diabetes monitoring apps or other essential medical tools.
- 3. During emergencies or safety drills where device access is necessary.
- 4. To support language access, including translation services for English language learners.
- 5. For caregiving responsibilities, as determined appropriate by a school counselor or psychologist.
- 6. When legally required, including accommodations documented in:
  - a. An Individualized Education Program (IEP)
  - b. A Section 504 Plan under the Rehabilitation Act of 1973

I used the first, for educational purposes, and teachers have seen me and they haven't said a thing.

Why? Because their job is to teach and mine is to do the work.

I was doing perfectly fine until this happened, and other events prior, and now I'm behind.

I tried to talk to the principal, the assistant principal came, mentioned the same thing and she was very rude about it.

Said they follow STATE POLICY.

Well, Ms. Brown.

### If you're looking at this, YOU look at the STATE POLICY.

Yes. Devices may be used:

- For educational purposes, as directed by teachers and authorized by school leadership.
- By students with medical conditions that require the use of electronic devices to monitor them, such as glucose monitors for diabetes. In this case, parents should inform the school and provide any necessary documentation to ensure proper authorization and usage.
- For translation services, to assist students who need language support not currently provided by their school.
- If required by an Individualized Education Program (IEP) or 504 Plan for medical or educational purposes, and the school has not yet provided a device for such purpose.
- By student caregivers, on a case-by-case basis. A school psychologist, school social
  worker, or school counselor will review and determine if exceptions may be granted
  for a student caregiver who is routinely responsible for the care and wellbeing of a
  family member.
- In individual emergency situations, when the parent has notified school leadership of the specific nature of the emergency.
- Where otherwise required by the law. This includes situations where federal, state, or local laws mandate the use of such devices for specific purposes.

Where again, I use the first exception where teachers have allowed me to use it because I use it for educational purposes.

And you ignored that, you wanted me to feel as if I don't know your OWN polices, that YOU should follow.

Surprisingly, I, again, saw OTHERS with other devices who used it for their own things.

At the end of the day, devices that were taken this morning, NOT PHONES, other personal devices, were supposed to be kept until 4:00 PM

Which no where on their policy says ANYTHING about it.

I've returned after a week, or weeks?

I've been missing school last week to slowly do my work as I recover, I've been doing good.

I've been feeling happy to actually like to do everything and now I've recently been having motivation to accomplish everything at the moment.

I've written emails to my teachers explaining the situation. Trying to speak to the district sometime soon, don't know when.

I honestly just don't feel safe and have the energy to deal with the pettiness.

Some kid out there said the same thing as me, I've heard, and they let them have his laptop.

THEY PLAYED GAMES.

So again, yeah, don't feel like dealing with that energy, ya know? It's nice being in a quiet area being able to be in my own thoughts doing my work.

That's honestly the best way for me to be okay, I just want my teachers to know since they're more sympathetic, staff will just blame me for what?

They're really immature and non-hearing.

I'm doing okay though, really better.

Peace out, until the next update.

So I went to my guidance counselor today to talk about it, not even a good start.

I've sent emails to my teachers explaining and they're supporting me in any way possible, I get they're different but they were more respectful and planning about it.

Anyways-

Walked in and she said "Good morning, Kevin."

I didn't ignore her, I just nodded my head down, as I am not that verbal unless I genuinely need to or feel trustworthy with.

I didn't feel safe as soon as I entered those doors.

But then after "ignoring" or simply "being rude", straight on has this rude tone in a louder voice repeating the same thing.

I said "Good morning" in a forced voice because again, I was not comfortable.

They explain the situation, tell my mom the absences, my grades, or at least current passing or failing state, and the reasons why, and consequences if not done anything to investigate and resolve it.

I pretty much tried to bring up most of the points I've said. I've taken accountability for the phone issue, read the policy and yes, I was wrong.

I could not keep it in my backpack, state law.

Lockers, depends but the school doesn't mention it and I honestly didn't want to deal with their bullshit.

They accepted it, obviously, because they want me to be wrong, they all do.

I then started to attack the attendance teacher for all the things she did.

Saying the things that she's attacked me with, all incidents.

1. My girlfriend ONLY told her she said it was a housefire, nothing else.

I was still there but standing somewhat away from them, because of something I will explain in a second, so I heard everything.

Right after, I stopped hearing and then I decided to step in but it was late, my girlfriend then told me, she was pressuring her to tell her everything, I got pissed.

I know that girl, she doesn't like talking to adults, we both have trauma from adults.. No use for helping in any way.

Even after the meeting, I told her the attendance lady said that she told her the whole story where she knew it wasn't how it went.

Even when they called my mom to tell her my girlfriend told her that, we talked, because we both have a good relationship with my mom, and told her the truth.

She usually doesn't hear all of the things that REALLY HAPPEN during these events and I've been trying to tell my mom that, they don't want to make it seem like my situation is important, only like I'm overreacting.

My girlfriend told us both, again, pressured to tell her the whole thing because we knew what could happen and honestly, we don't want things to get bad for people because these jackasses want to assume everything.

NEGATIVE TOWARDS THE STUDENT, ALWAYS THE STUDENT IS THE PROBLEM.

2. I told everyone what she said insulting me and honestly she couldn't really defend that topic considering she admitted it, whereas before, she didn't.

Except she couldn't defend what bad I did, just only making her late. Again, making her late is bad but I've tried many times to let her go alone and arrive on time. I've had my own situation and I didn't want her to get picked on by the staff either.

Again, mentioning how everyone there is in that "YN" culture, hood culture, so I asked, "How am I giving anyone there a bad reputation?" Nothing said so we switched to my guidance counselor.

Eventually she started mentioning that yes, there are people who do stupid stuff and that I'm pretty much going for big things in the future and that I speak a lot and that I'm pretty much going for an actual meeting without any of that cursing or standing up every time someone pisses you off.

Then asked why I didn't report to them, I didn't trust them. I've told them I grew up with unknown conditions and during the times, my "tantrums" were me being uncomfortable with how I was learning, pretty much, I didn't feel like I was welcomed.

And now that I know, it's been years to fix that, there's nothing I can do.

So with me growing up having to experience the same thing, students laughing, speaking bad about me for liking SIMPLE and GOOD things, having to speak to some security guards, staff members, I've only come to one thought, one truth to me.

There will only be one good staff member out there, the rest, if any problem arises and gets to a meeting, will be exactly how I was today. The sweet talking trying to make me feel like I'm being heard when I'm not.

All the good ones were out, especially seeing the way the security, attendance lady were, now I didn't trust anyone there.

Seeing that the students grew up and already followed such stupid culture, something that'll only put them down and ruin the world more, it was too late, I didn't trust anyone anymore, at all.

During this thought process, I was thinking, how would I want my life to be?

Do I want to continue following these broken rules? This unfair treatment?

Do I really want my life to be controlled by who I think will lead me to success?

Do I need grades, a piece of paper to tell them I'm smart?

Do I need to be trapped in a place where I could only ruin myself more?

I was thinking about crying, but I didn't, I really wanted to.

I didn't grow up with me fighting against me for unknown things, only to do good and not have anyone defend me because I couldn't speak. I wanted to speak now.

I wanted to drop out, I wanted to honestly just make myself suffer either way repeating the same chapter everyone's read.

I only depend on myself and then I still stood, I didn't let it fully get to me.

She then asked if it was just fears and then I mentioned the whole security thing, the attendance lady talking to US because we were showing up AGAIN late at the same time except I spoke for my girlfriend because she hates talking to people. (THIS IS WHAT I WAS TALKING ABOUT.)

It's also funny considering she doesn't remember this interaction where both of us do, we have good memories so she was rather lying or she actually forgot.

I told her this incident where during the time my girlfriend twisted her ankle, I helped her with holding her bag in the elevator and when I did, all of the staff were okay with it and if I didn't have a hall pass, they would say to get one but leave.

Then this one specific person comes in, asks if I have one, I said no, and yanks her bag off of me.

I told him to "Fuck off."

And left, it was bad of me to do that.

Then asked my girlfriend why she needed someone for that, it's her ankle being hurt, not her arms.

During private talks with my girlfriend, we both made fun of him asking if he's stupid because the bag is heavy, puts weight down to

the ankle.

Maybe someone needs more common sense.

I got called to his office to apologize to him, I did.

But he kept talking about his stupid wife who I did not care about, no one does, except for him.

Talking about how if I get him in trouble, she gets in trouble too. I really wanted to just tell him to shut up because I don't see other staff members mentioning their partners getting in trouble for stuff they did.

Then said something really disgusting.

Without a pass, it would be unknown to others and being boy and girl, I could've gotten my girlfriend pregnant there.

Again, during those private talks with my girlfriend, we made fun saying the timing doesn't work, no one can take off pants quickly without the elevator opening due to staff and students using it. It opens every 3-7 seconds.

I joked around asking if that's how long he lasts because honestly, how?

I told my mom, my girlfriend and her mom, we all found it disgusting.

Another incident was with a student who threatened to beat me up at the beginning of the school year, who I didn't report because they backed off after I started ignoring them in every way possible. That doesn't scare me, I don't fight, it's stupid. It was cyberbullying, harassment, and threatening.

Another was with a classmate of mine who kept annoying me to the point where I got irritated and left the room, I heard the laughs.

I was told the person didn't do that by accident, they did it on purpose.

They said they "can't believe it actually worked."

So yes, I'm sorry I didn't come to you for my problems. I've been walked over so badly I didn't think it would help, I still certainly don't feel like I'll be helped again. It's my fears and experiences in this school.

Other points; lazy to write.

"We follow law"

"Okay, then why did a student who arrived said the same excuse and got allowed to use it only for them to use games?"

My mom regrets having to see me go through it because I've tried telling her but due to staff wanting to ruin me, said only the bad

about me so she thought I was just being disrespectful.

I told my counselor I didn't like her attitude and she started to stand up her seat pretty much saying I was disrespectful in that exact rude loud voice, using her ethnicity as an excuse for "being loud." She also said I was being rude when I tried defending myself saying I can't because I don't trust or do that, with anyone.

I don't say good morning, goodnight, or good afternoon to people I don't trust.

It was a meeting and I wanted to get it over with, so I nodded down to tell you greetings.

They made a meeting with the principal, now I'm waiting for that. They've mentioned an IEP.

I also mentioned my ADHD, anxiety, important things I'll update when I don't feel as tired.

PEACE.

October 9, 2:20 AM.

Okay, so to fix my stuff cause I was tired as fuck and just sort of woke up from 2 naps, sleeping, whatever, I want to add up some stuff. Or thoughts.

They contradict themselves?

1. Why are they telling me to not say personal stuff?

There are some people who ask if we're dating because they just want to know, I've been asked A LOT sometimes and honestly, who COULDN'T assume we're dating.

I mean it's public, it's out there, unless they're not good with assuming.. And reading the room..

Either way, they assume and ask personal stuff just to make conversation no matter the situation or not.

Sometimes it's to make things clear on why things happen.

Like they've asked, since I'm a Sarmiento, they've mentioned my cousins but they didn't know them as my cousins.

So I clarified they're my cousins.

And because of how that school is, there's one out there who follows that stupid culture, it's gotten to a point where they just do that shit for fun, I don't even know the damn reason.

I talked to them alone, in person after walking and because for RESPECT, wanted to just see how it is since they sometimes ask how I am, they seemed like me, just nervous, not having A CLUE on what to say while I'm taking over the conversation.

Then at school, full blabbermouth about that stupid ghetto shit.

Then there's cousins who just live their lives in a normal way or some wacky way like mine, and they're better than me and the rest.

I just wanted to separate them from me and to also, in summary, pretty much just say I'm not their brother to them, I'm their cousin.

Because I've had people ask if they were related and then ask me if I was a brother or something.

Or they just assume that.

So, counselor, yes, some personal things have to be included. Something you said is that because you're Puerto Rican and Dominican and that's why you're loud.

I found that inappropriate and unprofessional as it felt like you were using it as an excuse for answering to my response which I said you gave me a negative tone based on the "disrespectful" welcome. It made me uncomfortable.

I want to be respectful but I want the same in return.

Honestly, being loud and having tones like that are personal and have nothing to do with being a certain ethnicity, or defined by ethnicity.

I don't think that was a fair explanation to give to a student, it pretty much came as being dismissive and avoided responsibility to how the conversation should be handled.

I respect your background, but it was unrelated to the topic at the time.

October 10, 3:58 AM

Hey, so fuck them.
They dismissed my case.
I recorded the meeting and transcripted it.

- Recording 1 Start (Almost done with meeting) -

Kev: Yeah, I've tried to tell you that, but you completely dismissed me by the point. I'm not dismissing you. I told you what the policy is, and I'm telling you what the policy is right now. And the policy is no internet-enabled device.

AP: And you're trying to argue to bring a laptop, which is an internet-enabled device. I was trying to stop talking. No, no, no, wait until Dr. Pierce comes back. This is Dr. Pierce's meeting, and he asked me to come in. So we're going to wait for him to come back, okay? He went to make the announcements, and he's coming back.

- End Recording 1 (Waiting for Principal) -
- Recording 2 Start (Principal comes back)

P: Sorry about that, but I have a meeting at 9. I had to give the announcement to the school. So can you just crack it up for me?

AP: He said he wanted to share something else. Uhm, I told him to wait until you come because-

P: What's that?

AP: -there's no policy that I created and there's no policy that-

P: Regarding what?

AP: -you created. Whatever the district did on its own, which it's allowed to do, is through the superintendent. So go ahead.

Kev: Okay. So yeah, that day where exactly when they took my laptop, I tried to go to her to contact her to uh, to tell-

P: Who's her?

Kev: Uh, uhhh, Miss Brown.

AP: No, you didn't come to me. I was standing at the main entrance.

Kev: Not directly, but since you were assistant principal, I w-

AP:I was standing at the main entrance, and it wasn't with your laptop, it was with your cell phone. And you refused to give your cell phone in whatever device it was. And you had a camera around your neck. And I told you the camera you can keep, but any other device that's not internet enabled, and you were arguing back and forth with the security officers.

Kev: No, no, no-

AP: And I said to them, as long as a child is arguing, do not respond. And I told you what the rule was, and I walked off back to my post. But tell us the issue that you're having today going forward.

Kev: No, that I already said that was completely my fault.

P: Yeah, yeah, you already said that.

AP: Right, so let's look at

Everyone: [Unintelligible]

Kev: -The other day-

AP: Dr. Pierce, the parents are already here.

P: Parents are already here? Okay, all right.

Kev: But as the other day when you tr- when I came up to you in the main office, when I tried to tell you about my computer being taken away, when I tried to use the educational purpos-

AP: And I said to you-

Kev: That you follow state policy, but you didn't tell me you follow district policy and tha-

AP: Of course I, that, I, of cour- [laughs]

P: Alright, so, so, alright let me just-

AP: Of course I follow district policy. I don't work for the state. I work for the district policy.

Kev: Now that you said that,

AP: Okay...

Kev: Quote, exceptions for education on essential use, student use of internet-enabled devices

may be permitted. Student use of personal internet-enabled devices may be permitted u-

AP: Maybe-

Kev & AP: Maybe-

AP: And we're not permitting it because if something is wrong with your device speak [Unintelligible]

Kev: One, for educational purposes when authorized by a teacher administrator, you can ask any teacher from last year at the beginning of the year.

AP: So we're not authorizing it because we have laptops in the building that we can give you.

P: Let me just, let me just finalize this so-

AP: [Laughs]

P: So the superintendent already made his claim that no laptops are allowed-

AP: Right.

P: -In the Mount- In Mount Vernon City School District. You could read all of that of what they're saying-

AP: And it says may, MAY.

P: But the district has a standpoint on this. Not us. We follow what comes from the district. Kev: Then how come the security allow others to have it?

P: No. So. The district says that no one is allowed to bring their personalized laptop. Now, I still don't understand what we're talking about because you have a laptop. So the issue for me is not what's happening. The issue for me is, do you have a functional laptop?

AP: He said it's slow. So we can update it.

P: You have a laptop, but it's slow. So, because I'm not thinking about solutions.

AP: Mhm.

P: Moving forward, you go to Ms. Crossstore or Patma Zone during your lunchtime. It has to be during lunch. Tell them what the issue is.

Kev: Can't today, I have a common assessment.

P: Tell them what the issue is. And then they will look into it, clear the tech links, and they will fix

that for you. So that means now that you'll have a functional, speedy laptop to viewer, no problems. Going into the past is not going to undo anything. That's what happens with the past. The past does not change. Because we could talk about the past another million times. It's still not going to undo the past. What we need to talk about is right now. Right now, your laptop is slow. You want it to get boosted. Let's try and boost your laptop. If you have to get a new one, they'll decide that. I can't. They're going to decide that. They have the tech link. And then we'll give it to you so you can get your education, which is my primary concern. I want to make sure you have a device where you can have your education when you're here and when you're not here.

Kev: That's really the problem. Why don't you change your policy?

P: No, no, it's not. It's not my policy. When it said my policy, it's not my policy. It's a district policy. So then if you have a problem with the policy, that means now you'd have to take it to the board to, which, you know, but they want us to take care of it. But they will- they will tell you the same thing. If you go there, they're going to tell you the same thing. It's not allowed. And-

AP: And Mr. Pierce, may I interject? If for whatever reason we ran out of laptops, we didn't have laptops, then that's where the may comes in. Because like he said, it's for educational purposes. P:But even then-

AP: But, but we have laptops.

P: Right.

AP: But we have laptops. So that doesn't, that doesn't come in effect. No one, no administrator or teacher is going to allow you to have a personal device because we have devices that we can give you. If your device is slow, they'll fix it. If they can't fix it, they'll give you a new one.

Kev: Then tell that to the security and all the other administrations who allowed it until this day?

P: To do what?

Kev: Then tell that to all the other security, and other administrators-

(End of Recording 2, CUT OFF DUE TO THEM SAYING THEY HAVE TO GO TO A TOWN HALL WITH PARENTS)

I will share my thoughts soon.

They are slowly mentally and physically draining me. I can't do this anymore.

My ADHD makes it difficult, hard to focus when this PIECE OF SHIT LAPTOP works so FUCKING SLOW and they say "TRY TO BOOST YOUR LAPTOP." Well because you told me "MAY BE" well you'll "TRY" so that doesn't fully guarantee it'll "boost" it quicker, at best probably an additional 2 tabs before it starts slowing down again. (Literally 3-5 tabs slows that crap down.)

I literally HAVE a personal life to get to, it's not that I'm immature or irresponsible, I WANT my personal life too.

I don't want to do this stupid shit.

You know how exhausting it is to do my work at night?

And you're probably like, "Well do it first then do your own thing." NO, because we're teenagers and we CAN'T hang out during the NIGHT, we ALL have time limits.

And I NEED to socialize, it literally boosts me in a positive way and doing THIS is affecting me negatively.

I literally have to adjust my schedule and have to eat so much JUNK from the outside because I feel like I don't have time to socialize and go OUTSIDE to balance myself.

Which literally sometimes causes me to starve myself because I HATE junk food so much.

I want a NICE home cooked meal everyday and because of this shit, I have to eat it every once in a while.

"Well eat the leftovers!!!"

NO, I WANT IT TO BE RIGHT THERE IN THAT MOMENT, IT LOSES ITS VALUE AFTER ITS COLD. (semi.)

AND NO, I SHOULDN'T HAVE TO EARN REST BECAUSE OF MY STUPID WORK.

I'M LOSING SLEEP JUST TO KEEP UP WITH MY WORK.

SLEEP, I'M 15, I'M GROWING, THIS IS PERMANENT.

I just want this to be over already, sometimes I feel like I'm losing myself.

How much of myself do I have to sacrifice just for A GRADE.

Just for A PIECE OF SHIT PAPER WHEN PEOPLE CHEAT FOR IT.

I WORK HARD AND SACRIFICE JUST FOR PEOPLE TO CHEAT AND EARN AND GET A JOB AND GET PRAISE FOR CHEATING THEIR WHOLE LIVES.

I'm tired of people telling me I can't change anything, and I still try.

I worry about everything, everyone, if I could explain why, I would. In summary, or the best, or I think, I just want justice for all.

## **VIOLATIONS**

### **VIOLATIONS:**

### DASA Act.

They violate my rights as a student.

For sure, the DASA Act under New York's law.

They have rules for the DASA Act.

The DASA Act should protect all students from discrimination based on, but NOT LIMITED TO, race, weight, national origin, ethnic group, religion, religious practices, mental or physical ability, sexual orientation, gender identity, or sex.

While also, "DASA defines harassment and bullying as the creation of a hostile environment by conduct or by threats, intimidation, or abuse, including cyberbullying. This includes threats, intimidation, and abuse that occurs verbally, non-verbally, or on any form of electronic communication."

My incidents have made me decline, hardly, through mental, physical, and education wise.

Which under that law, would create a hostile environment.

#### It also does say:

"This includes conduct of such a severe or pervasive nature that it has one or more of the following effects: Interferes with a student's educational performance, opportunities, or benefits

Affects the students mental, emotional, or physical well-being

Causes emotional harm that unreasonably and substantially interferes with a student's education

Causes, or could reasonably be expected to cause, a student to fear for their physical safety"

They have interacted with my educational performance, taking my laptop away, while yes, they give all of us school computers, I'd prefer my laptop and like any other adult, they would say to goof around.

No, I like to be mature and focused on my work.

Sure, I'd like to watch a movie but I don't because I shouldn't.

Again, ask any old staff member and they'll agree.

This year, everyone is confused. Staff should be "right."

Administrators should be "right."

Teachers should be "right."

But no one knows what to do.

Teachers usually say use school property but I've brought my laptop enough to prove I use it educationally unlike others who don't who I've seen today and the days prior.

Which is unfair, I use it for education purposes and the others don't.

This has also been affecting my mental health, I've started bringing up habits that I've stopped for a while when everything was smooth. They're harmful which is all I need to explain, I do not need to explain further.

Emotionally, I've always been picked on and trusted adults so seeing both parties go against me hurts even more.

Students just dislike me for being me, it makes it seem like being with me looks like a punishment.

I can't sit next to anyone without anyone laughing at me for:

- 1. What I like, what I do.
- 2. Sitting near people who have a certain type of style and I don't fit in.

Adults, I thought I could talk to them but staff don't even care anymore.

Security is picking on me.

Ignoring me when I'm asking for help.

It hurts, even outside of school.

I don't just have problems there, it's everywhere but I'm not getting into that.

Physically, I'm failing.

I haven't been able to sleep during the school week.

I've been up doing my stuff at night, work too but I never finish it because I'm tired.

I can't even look awake at school so I almost fall asleep or can't function properly.

Because I've dealt with mental health issues, my eating is now failing too.

I used to be able to eat more during the summer over a problem I had that ties in with my mental health but now again, I haven't been able to eat as I constantly feel nauseous, which for my mental health, means I'm nervous.

I'm always nervous to go to school which makes me hungry during the night as I can't be seen at night as I'll get in trouble for being awake.

Which means my schedule is to stay awake trying to do work, personal things, and sleep around 3-5 in the morning.

Wake up at 7-8 and get to school.

I struggle staying awake the whole day and then go home.

After that, I eat one meal and rather go outside to distract and keep me awake or go to sleep and wake up around 10PM-12AM. Then restart.

Honestly, being there at the school makes me physically afraid, there's so many people there that if you piss them off once, it goes to a LOUD argument, even one small wrong thing and it's a whole fight.

I can't even be honest about anything IN school.

And if you think that's no big deal, there have been people in groups harassing after school or in school too.

So it's not just a one-time thing.

As well as the first incident I had where the security guard lifted his hand and stepped closer almost like he was going to punch me. They held him back and he backed off.

I've also been just emotionally drained enough to even focus on school.

I try to make myself happy by interaction from the outside or internet world.

Nothing school related.

The work feels like too much even for a single question, it feels like I'm just sinking into failure in the most important year of high school.

## Amendment Rights.

They might have violated my Fourteenth, Fourth, and First Amendment Rights.

I have valid reasons and arguments to support myself with this statement.

Including highlighting and quoting the Amendment Rights.

#### Fourteenth Amendment:

"Section 1

All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws."

Due process refers to fair treatment, including fair procedures when the government acts against me in any way. This case would be the school.

My laptop should technically be confiscated with a clear reason being no personal devices with exceptions, district rules. But also says:

"Exceptions for Educational and Essential Use Student use of internet-enabled devices may be permitted: Student use of personal internet-enabled devices may be permitted under the following circumstances:

- For educational purposes, when authorized by a teacher or administrator
- 2. For health-related needs, such as the use of diabetes monitoring apps or other essential medical tools.
- 3. During emergencies or safety drills where device access is necessary.
- 4. To support language access, including translation services for English language learners.
- 5. For caregiving responsibilities, as determined appropriate by a school counselor or psychologist.
- 6. When legally required, including accommodations documented in:
- a. An Individualized Education Program (IEP)
- b. Section 504 Plan under the Rehabilitation Act of 1973"

My laptop goes for the Educational Purposes exception so it doesn't work.

Teachers have seen me use my laptop last year and the beginning of this year with no problems or complaints about it unless it's out without use of the class.

They even allow me to charge it but keep it closed when not necessary. I've tried explaining but they didn't hear me out, barely even said it. (Explained later.)

And the school policy, not the district, says no phones.

But doesn't say anything about personal devices. They should technically be following the rules of the district but based on things I've seen, they're doing whatever they want.

With their "fair explanation," it's said I can't have a personal device but with evidence, others do, IPads, non-school laptops. So it's not really fair at all.

There was no clear explanation because one may fight with the metal detectors, why are they making a problem about it now?

Again, while others have it NOT for education purposes?

Schools should have procedures when taking it but they don't have evidence that I have been doing any wrong doings or violated anything which means they took my property without proper process.

They should've taken away the students who had their devices for other purposes unlike mine, for educational purposes.

My due rights and my rights to equal treatment may have been violated.

#### Fourth Amendment:

"The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized."

For the school to search my bookbag, they need a reasonable cause. One would be for the phone or anything suspicious that I may carry, pretty much something serious going against policy, rules, etc. I didn't have a phone, there was no need to.

They have metal detectors to see if I have anything there, I didn't.

My laptop always shows there if it goes through, along with anything else, they've ignored it last year and the beginning of this year. I, again, use it for academic purposes meaning there were no grounds to search my bag, or seize my property.

Their cause was because it wasn't school-issued.

Your district policy says exceptions, I used the first.

And if it doesn't work, you let others have theirs with no exceptions, teachers complain.

Your school says phone, I didn't have it.

There was no valid cause, my Fourth Amendment rights may have been <u>violated</u>.

First Amendment:S"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

My laptop was for academic work that gave me the ability to express myself, my own words.

They have restrictions on free speech, everywhere it does, as long as it's not disruptive.

And I know they'll use that against me but for what?

For telling them facts about how unfair today and the past weeks have been?

I've never lifted my hand to physically harm property or anyone on school grounds.

I've never raised my voice to make a scene for others to hear, the staff did to shut me down but I raised to be heard, not because I wanted to.

I never cursed at anyone, that's unprofessional knowing once I do, they'll have a reason to take me to admin but I know better.

Other than that, the laptop was used to complete academic work and taken without fair reason.

They impeded my right to use my laptop for education and expression, my First Amendment rights may have been <u>violated</u>.

In violation, possibly but likely, district rules (not following, ignoring my use of my personal property, state policy (tried to use that against me but it says the same thing, educational use and i did), constitutional rights (read up), DASA obligations (read up), and unequal discipline (allows some students to have their devices with no exception, no talking, and while mine with me trying to defend myself, i didn't get to have mine.)
