 - b. Statement of minutes from the church council supporting this ministry indicating its support for this application and the amount requested. (In some cases, this statement can be provided by a governing board or committee [Campus Chapel, etc.]

After reviewing applications, Specialized Ministries committee will forward recommendations to the Classis Lake Erie executive committee. You may appeal recommendations to the executive committee or to the classis at the Fall meeting.
